

Forewords



This report summarizes the academic activities and achievements of the Aix-Marseille School of Economics (AMSE) during the civil year 2015. One of the central events of the year was the launch of the Ecole AMSE, which restructures and unifies our graduate program, under the direction of Carine Nourry.

Our community has now reached quite a critical mass with 94 permanent researchers, 13 postdocs and 81 doctoral students. Given the flows in and out, we might be close to an equilibrium. In 2015, we welcomed 6 new researchers – Nicolas Berman, Timothée Demont, Giorgio Fabbri, Céline Poilly, Eric Strobl and Roberta Ziparo, 5 postdocs and 16 doctoral students. On the other hand, 7 researchers and 2 postdocs left. Twelve doctoral students defended their dissertation, 9 of whom are pursuing their career in research and academia.

Publications are on par with previous years and include 84 articles in peer-reviewed economic journals, among which 23 in the top journals according to CNRS, 29 articles in other disciplines, 12 book chapters and 3 books. Scientific life is flourishing with notably 4 globalization lectures, 122 seminars, 4 conferences and 13 workshops. Our flagship conference, the Journées Louis-André Gérard-Varet, is nicely growing and has become one of the main international conferences on public economics.

Overall, AMSE is consolidating its position of academic excellence in teaching and research. In August 2016, our ranking among economic departments according to REPEC was 3rd in France, 16th in Europe and 52nd in the world.

Forewords



The EcAMSE project aims at developing in Aix-Marseille University the Ecole AMSE, a department of the FEG, Faculty of Economics and Management (FEG), providing world-class programmes in Economics, Econometrics, and Finance, and delivering Magistère, Master and PhD diplomas.

The main goals of the Ecole AMSE are to:

- provide high level class training in economics at a fraction of the price charged in most universities around the world.
- train students to become Economics Engineers with a strong background in quantitative economics and finance, mathematics, econometrics, and Big Data analysis;
- place graduates in the best universities and companies around the world;
- attract students from all over the world.

Our project was approved by A*MIDEX in February 2015, and the school EcAMSE opened on 7 September 2015. Since the launch, our aim has been to develop awareness of the school, to enhance its attractiveness for students and for potential employers, in France and abroad, and to ensure our programs successfully meet job market requirements. During this first year, a number of actions were taken to reach our goals.

We have included a high level Big Data programme in the curriculum. This programme relies on the strong competences of our faculties in econometrics and for the most specific part has been designed with the help of highly qualified professionals in Big Data analysis and will allow us to compete with the best school providing training in Data Science.

We have further developed courses taught in English, established and deepened strong links with foreign universities, not only for our outgoing students but also to attract more students from abroad at a fraction of the cost charged in many top universities in Europe as the Magistère registration fees are low.

We have also set up the Development Council (Conseil de Perfectionnement) of the school including professionals, faculties, administrative staff and students. It is a kind of think tank in charge of evaluating the relevance of our programs and making suggestions in order to better meet employers' needs. It helps us to develop our relationships with prestigious companies who play an important role in the economic and industrial fabric and help us to set up our programme according to the needs of the labour market. Different issues and a number of ideas have already been identified in order to develop the vocational scope of the curricula.

We have changed the pedagogy with an increased orientation to individual and collective projects with transverse projects and tutored projects. Project Management is included in the curriculum and taught by professionals. We have developed a website both in French and English http://amse-feg.univ- amu.fr/fr to ease the access to information for French and international applicants (there is already a significant increase in international student applications for the first year of the master 1: 502 in 2015 against 863 in 2016). The website contributes to developing the outreach strategy of Amse and of the university throughout the world.

We have launched a communication plan about the program, targeted both towards other universities, in France and abroad, and towards public institutions and firms, and have involved students in these actions. We have also started to gather information about professional insertion, to work on our alumni network and to liaise with the private sector and public institutions.

We have created a school spirit through the organization of regular social events, set up "office hours" during which our students can meet faculties, launched an internal online newsletter for our students written in English and distributed by mail, helped students to create a Junior Enterprise called Junior Data Analysts. We also highly encourage the student association which has become really active this year, and each new student in the school can benefit from the help and assistance of a second or third-year student.





Olivier Bargain nominated for the Prix du Meilleur Jeune Economiste de France 2015 (Best Young Economist of France)



GREQAM researcher Olivier Bargain, aged 38, was nominated on Monday 18th May for the prestigious Prix du Meilleur Jeune Economiste de France 2015. Awarded jointly by the newspaper Le Monde and Le Cercle des Economistes. in conjunction

with the French Senate, the prize is given to a French economist under 40 "who combines recognised expertise and active participation in public debate". The prize, launched in 2000, this year went to Pascaline Dupas, a specialist in development policies at Stanford (USA).

Over the past ten years, Olivier Bargain has published numerous articles reporting important findings that help explain socio-fiscal institutions and labour supply behaviour. His work today combines two threads, calibrating a behavioural model on the basis of experimental approaches aimed at strengthening the credibility of simulation models and their predictions. "A concrete example is the reform of the RSA (French income support benefit): we calibrated a model on the pre-RSA years which gives good results in terms of predictions. Using this model, I show that extending the RSA to the under-25s – a powerful anti-poverty measure – would not lead to massive reductions in employment among this group, as certain people fear."

After preparatory studies at the Grandes Ecoles in Toulouse, Olivier Bargain attended Ecole Supérieure de Commerce de Paris. He obtained a DEA from EHESS at the Paris School of Economics, followed by a PhD under the direction of François Bourguignon. He then worked abroad for seven years, two years as a Researcher at the German Institute for the Study of Labour (IZA, Bonn) and five years as a Lecturer at University College Dublin (Ireland). He joined Greqam and Aix-Marseille School of Economics in 2012.

Jason Shogren, awarded by Aix-Marseille University



Jason Shogren (University of Wyoming) was awarded "Docteur Honoris causa" by Aix-Marseille University on November 12, 2015. A Workshop on environmental economics in honor of Jason Shogren was organized at this occasion by AMSE-Gregam.

Officials at Aix-Marseille University (AMU) bestowed the "Docteur Honoris Causa" upon Shogren in November. He was chosen because of his reputation, impact on the scientific community and collaboration with AMU faculty members. He had collaborations with AMSE since a long time.

Currently the Stroock Professor of Natural Resource Conservation and Management in the UW College of Business's Department of Economics and Finance, Shogren shared the 2007 Nobel Peace Prize with former Vice President Al Gore and others for his work on the Intergovernmental Panel on Climate Change. He also has been named a fellow of the Association of Environmental and Resource Economists, a pre-eminent professional society for environmental economists and policy.

In 1997, he was the Clinton administration's senior economist for environmental and natural resource policy, Council of Economic Advisers. In 2008, he was appointed as a lifetime member of the Royal Swedish Academy of Sciences, a group that annually awards the Nobel Prize in physics, chemistry, literature and economics.

Jason Shogren has left an indelible impact on the profession of agricultural and applied economics. His work on the behavioral underpinnings of decision making has influenced many aspects of public policy, gained the attention of international organizations, and helped guide the careers of many of his students.

Shogren's research has made him an expert on a smorgasbord of topics under the heading of applied microeconomic theory, including environmental and natural resource economics and public finance, and public choice. He also has worked on experimental economics and applied econometrics. The effects of his academic research have extended beyond academia and into public policy. He has worked on highprofile projects initiating environmental policy, including the Kyoto Protocol and the U.S. Endangered Species Act.

His range of expertise has contributed to a dozen books, over eighty book chapters, and more than 200 journal publications on endogenous risk, endangered and invasive species, experimental methods and behavioral economics, valuation experiments and survey instruments, application of game theory to environmental issues, the integration of life sciences with economics, and even paleoeconomics.

2.2) PhDs and postdoctoral fellows


PhDs

In 2015, AMSE had 81 doctoral students. The number of doctoral students was 80 in 2014 and 54 in 2013, prior to the integration of a new research team.

At the start of the 2015-2016 academic year, AMSE welcomed 16 new doctoral students, of whom 9 are men and 7 are women. Seven of them are from France, 2 from other European countries and 7 from countries outside Europe. Eleven of them graduated with a master's degree from AMSE, 4 graduated with a master's degree from another French university and 1 from a foreign university.

In 2015, 12 doctoral students defended their dissertation. Nine are pursuing their career in research and academia. Among them, 6 found a position in the international job market: one is lecturer at Hong Duc University (Vietnam); one is assistant professor at the College of Business and Economics, Qatar University; one is a postdoctoral fellow at Catolica Lisbon School of Business & Economics; one is an economist at the Montréal Economic Institute, one is a chief economist at TAC Economics, and one went back to his position of professor of medicine at the Dartmouth Institute. Two are now assistant professors at a French University (Université Paris Est Créteil Val de Marne and Université Lyon 2) and one joined SESSTIM.

Predoctoral grants

Each year, AMSE offers grants to doctoral students from other universities in their 4th or 5th year. In 2015, 4 grants were awarded, to Ugo Bolletta (University of Bologna), Yannick Dupraz (Paris School of Economics), Brice Fabre (Paris School of Economics and EHESS), and Guillaume Wilemme (Sciences Po Paris).

Postdoctoral fellows

In 2015, there were 13 postdoctoral fellows at AMSE. Seven fellows had done their PhD abroad, 1 under dual French/foreign supervision and 5 in a French university.

Mobility and visiting program

Coauthorship (short visits of or to coauthors) is financed by Labex AMSE.

In 2015, 16 researchers welcomed a coauthor, generally for one-week periods. There were 16 such coauthorship visits in 2014 and 17 in 2013.

In 2015, 7 AMSE researchers visited a co-author. The year before, 8 AMSE researchers had visited a co-author, and 6 had done so in 2013.

Two post-doctoral fellows welcomed a co-author in 2015.

Labex AMSE also supports doctoral student mobility opportunities. Long stays, from one to four months, were made possible for 11 doctoral students in 2015.

Siwan Anderson

Siwan Anderson is a professor at the Vancouver School of Economics in Canada. She obtained her PhD in 1999 at the University of British Columbia. She has previously held academic positions at Tilburg University and the University of Melbourne. She is currently an associate of the Canadian Institute for Advanced Research (CIFAR), a Fellow of the Bureau for Research and Economic Analysis of Development (BREAD), and an Associate of Theoretical Research in Development Economics (ThReD). Siwan is a development economist whose research focuses on micro-level institutions and gender.

Seminal work in development economics over the last decade has demonstrated the importance of institutions in explaining differences in income levels across the world. This macro focus has more recently led to more micro-level analysis of institutions to complement the empirical work that has examined cross-country differences in institutions. One main strand of Siwan's research falls into this theme - an analysis of micro-level institutions in poor countries.

To this end, she is currently involved in two large-scale data collection projects in the state of Maharashtra in India. The focus is on village-level governments and the implementation of key poverty alleviation schemes.

A second main research focus is on women in developing countries. Siwan's research has addressed the issue of "missing women" in the developing world and explored key determinants of excess female mortality. Another focus is women's access to property rights and the subsequent economic implications at both the household and political level. A very recent project aims to combine the two focuses of gender and institutions and directly study traditional female political institutions in rural Africa.

Siwan is delighted to be visiting AMSE for the academic year (2015-2016) and to be interacting with the growing group of micro-development economists within the faculty at AMSE. This is a group of mainly young scholars with exciting research projects currently being conducted in parts of India and Africa. Their interests are directly related to Siwan's and there is much research overlap. There are also a number of PhD students and Post-docs working on related issues and Siwan is enjoying engaging with them at the different stages of their research.



Patrick Francois

Patrick Francois received his PhD in Economics from the University of British Columbia in 1995. He has held positions at Queen's University, Tilburg University, The University of Melbourne and since 2001 The University of British Columbia. He is a fellow of BREAD, ThRed, CMPO, CEPR, CIFAR and is in his second three year term as a Co-Editor of the Journal of Development Economics.

Patrick's research focuses on development economics, concerned mainly with institutional issues - extending from political economy, to norms of cooperation and trust. He is an applied theorist, often working with complementary researchers that have the skills he lacks: i.e., econometrics and formal proofs without hand-waving.

His main collaborator at AMSE is Tanguy VanYpersele, with whom he has been working on establishing that competition across firms builds trust across people.



This research aims to shed light on one of the main questions in the social sciences: why are humans able to sustain such high levels of pro-sociality amongst non-genetically linked individuals relative to other animals? He is excited to interact with the large number of like-minded researchers and PhD students at AMSE.


Publications


In 2015, AMSE researchers published 113 articles in academic journals, 12 book chapters and 3 books. The respective numbers for 2014 were 134 articles, 28 book chapters and 6 books.

AMSE researchers have a significant interdisciplinary production. Among these 113 articles, 84 were published in economics and 29 in other disciplines such as mathematics, philosophy and medicine. In 2014, AMSE researchers published 107 articles in economics and 27 in other disciplines.

The CNRS ranking of economic journals can help get a sense of the quality of the publications. *In 2015, AMSE researchers published 23 articles in journals ranked 1 or 1**, 28 articles in journals ranked 2, 17 articles in journals ranked 3-4 and 16 in unranked journals. In 2014, AMSE researchers published 28 articles in journals ranked 1 or 1*, 32 articles in journals ranked 2, 35 articles in journals ranked 3-4 and 12 in unranked journals.

AMSE researchers also wrote 52 AMSE working papers in 2015, compared to 58 in 2014 and 60 in 2013.

External Shocks, Internal Shots: The Geography of Civil Conflicts

Nicolas Berman and Mathieu Couttenier Review of Economics and Statistics, 97(4), 758-776, 2015.

The research program

Since World War II, civil wars have affected more than a third of the countries in the world. An extensive research has tried to study the deep determinants of internal conflicts, focusing in particular on long-term institutional problems, ethnic fractionalization, inequalities or resources abundance. A strand of this research has also focused on the impact of income variations on conflict. The literature has faced important identification challenges, as: (i) all these determinants might also be consequences of wars; (ii) many of these factors are correlated with each others at the country-level, which makes it difficult to disentangle their respective contributions; (iii) many of these factors might affect conflicts through multiple channels. The paper discussed here belongs to a general project which tries to overcome these various issues and to provide a deeper understanding of the economic causes of civil conflicts through the use of extremely disaggregated and detailed data.

Paper's contributions

The relationship between income and conflicts is especially difficult to address causally. To identify exogenous variations in income, some papers have used rainfall as an instrument for income in agriculture-based economies. Others have considered commodity prices variations as a proxy. The results have been mixed results at the very least, and, with few exceptions, these papers have failed to properly document the channels through which income variations affect conflict risk.

Theoretically, changes in income have an ambiguous effect on conflicts. On the one hand, a higher income might decrease the risk of conflict, either by reducing the individuals' opportunity cost of insurrection or by increasing the capacity of the state to prevent rebellion. On the other hand, positive income shocks might impact positively the likelihood of conflict by increasing the value of resources to fight over.

The idea of our paper is to use detailed information on the precise location (longitude and latitude) of violent events in Sub-Saharan African countries to assess the effect of external income shocks on the likelihood of violence. We make the following contributions. First, we propose a number of alternative ways to identify exogenous income variations based on international trade patterns. In particular, we combine original region-specific measures of agricultural specialization with temporary fluctuations in world demand for agricultural goods. We also go further than the existing literature by considering a number of longer-last-

ing external demand shocks, such as financial crises or changes in foreign trade policy. Second, we assess the effect of income shocks both at the micro and macro levels, and investigate how these shocks affect conflict incidence, and how their effects vary across locations. In particular, we combine our shocks with location-specific information reflecting their "natural" level of trade openness, proxied by the relative distance to the nearest major seaport.

Our analysis yields several results. First, the incidence, intensity and outbreak of conflicts are generally negatively and significantly correlated with external income shocks within locations. Second, this relationship is significantly weaker for the most remote locations, i.e. those located away from the main seaports. Third, at the country-level, only large, long-lasting shocks - financial crises, trade policy - have an effect on the outbreak and location of new conflicts. More generally, our results therefore suggest that external income shocks are important determinants of the intensity and geography of conflicts within countries, and provide support in favor of the opportunity cost theories of war. Our paper also contributes to the literature documenting the effect of trade and globalization on political instability.



Nicolas Berman has joined AMSE-GREQAM in December 2015 as an A*MilDEX junior research chair. He obtained his PhD from University Paris I Panthéon-Sorbonne in 2008.

Before joining the AMSE, he was Max Weber Fellow at the European University Institute in Florence, Assistant and then Associate Professor at the Graduate Institute of International and Development Studies in Geneva. He is also a CEPR research fellow.

Research process and future research

The process of research, writing and revision of this paper went quite smoothly. The data construction was an important part of the work, on which we capitalize in current research projects. We are now working with an extended team on various papers related to the determinants of civil conflicts. A first project (with Mathieu Couttenier, Mathias Thoenig and Dominic Rohner from the University of Lausanne) tries to understand how natural resources (specifically, minerals' extraction) affect and diffuse conflicts over space. Another (with Mathieu Couttenier and Raphael Soubeyran from INRA-Montpellier) studies how changes in soil fertility affect conflicts over land in Sub-Saharan African countries.

Effect of a Community-led Sanitation Intervention on Child Diarrhoea and Child Growth in Rural Mali: A Cluster-randomised Controlled Trial Pickering

The broader research program

One billion people worldwide still practice open defecation. Of the 2.5 billion people without access to an improved sanitation facility, 70% live in rural areas. Progress in gaining access to improved sanitation has been slowest in sub-Saharan Africa, where sanitation coverage only increased by 5% between 1990 and 2012.

In this paper, we evaluate the effectiveness of a community-based sanitation program in rural Mali, focusing on its potential impact on health. We ran a randomized controlled trial across 121 villages (about 4500 households) in the region of Koulikoro over a two-year period.

The program's objective is to help villagers abandon poor sanitation practices through community mobilization. This approach contrasts with the traditional policy solutions involving subsidies or hardware provision, which are plagued with low take-up. Community-based programs that aim to foster ownership of policy issues and help communities find local solutions are considered by many (especially outside the field of economics!) to be cheap and effective ways to obtain sustainable change. Community-based sanitation programs operate in over 20 countries with the support of the main international organizations.

The paper's contribution

It is biologically plausible that poor sanitation, through unsafe disposal of human excreta, increases the risk of infections and leads to poor health outcomes, especially among young children. In rural Mali, where sanitation infrastructure is not publicly provided, health outcomes may be endogenous to sanitation choice. Before the start of this study in 2011, there was no clear-cut evidence on the impacts on health of sanitation interventions. Since then, six other randomized experiments have been completed. However, in all these cases, adherence to the program, as measured by change in sanitation practices, was weak, and no effect was ultimately found on health outcomes. In contrast, we find that access to private latrines was almost twice as high in intervention villages (65%) compared to the control villages (35%).

Biological pathways from poor sanitation to growth faltering in children are becoming the object of fierce debates among public health experts. Rather unexpectedly, we contribute to this debate by offering the first piece of evidence suggesting that sanitation may prevent growth falte-

ring through pathways other than diarrhoea reduction. Indeed, we found no effect on diarrhoea incidence. Yet there were significant improvements in child growth, particularly in children under 2 years of age. Children in intervention villages were taller, less likely to be stunted and less likely to be underweight compared to children in control villages.

The research process

This work is the result of an inter-disciplinary collaboration led by Maria Laura Alzùa who is an economist at Universidad Nacional de la Plata, in Argentina, and myself. The project stems from discussions with UNICEF policy experts from headquarters in West Africa. We convinced UNICEF to go beyond the usual monitoring approach and to provide us with the necessary support to conduct a randomized control trial. The research project also benefitted from input and support from Nicolas Osbert, at that time manager of the water, sanitation and hygiene division at UNICEF in Mali, and of Moussa Cissoko, head of the Department of Sanitation in Koulikoro.

We were lucky to learn that the Bill and Melinda Gates foundation were looking to fund a series of research projects in the area of sanitation, and even more lucky to learn that ours was being funded! Fieldwork came with its own lot of surprises. But, despite the conflict in Northern Mali that erupted between our two rounds of data collection, the project was successfully completed (with the added advantage that we had more time to conduct the experiment than the Gates foundation initially allowed us to take).

Future research

We are now interested in understanding how this program has led so many households to change their behavior without providing them with financial support or hardware. From an economist's point of view, this intervention can be seen as providing information and educating villagers on the returns to better sanitation practices. But this may not be all. Indeed, besides being practical, conducting the intervention at community level rather than at individual household level may stimulate social stigma against the old practices, and in turn explain the massive change in behavior.

Habiba Djebbari is a professor at Aix-Marseille University. She obtained a PhD

in Agricultural and Resource Economics from the University of Maryland College Park in 2004. Prior to joining GREQAM, she was first an assistant professor and then an associate professor at Université Laval in Québec between 2004 and 2011. She also is an IZA Research Fellow since 2005.

Indeterminacy and sunspots in two-sector RBC models with generalized no-income effect preferences

The broader research program

We explore the idea that waves of pessimism and optimism of economic agents may be a significant driver of the business cycle. A requirement from the rational expectation assumption is that such exogenous changes in agents' «sentiments» must be self-fulfilling. For example, negative expectations of consumers and firms - leading them to reduce consumption and investment - must induce a decrease in output consistent with the initial expectations. In dynamic macroeconomic models, a simple way to introduce self-fulfilling changes in expectations is to consider models that are locally indeterminate. This means that, for a given economic environment, there are several equilibrium trajectories converging to the steady-state. In this case, agents' expectations play the role of a coordination device that selects one trajectory among many possible, and changes in expectations generate endogenous economic fluctuations. Our broad research program is thus to propose and analyze models that feature this local indeterminacy property, and to investigate whether models of this kind can account for salient features of observed business cycles when submitted to random shifts in expectations.

The paper's contribution

A major difficulty with one-sector growth models with endogenous labor supply is that they tend to require implausibly large degrees of Increasing Returns to Scale for the local indeterminacy property to emerge. By contrast, two-sector growth models require much lower degrees of Increasing Returns to Scale. At the same time, when we started working on the paper, these models were believed to have very poor business cycle properties. One contribution of this paper is thus to show that these beliefs were wrong. If we consider a class of individual preferences consistent with low income effect on labor supply, we can prove that two-sector models not only feature the local-indeterminacy property easily (i.e., for a large set of empirically credible calibrations of structural parameters), but also that they generate business cycle properties that are consistent with observed stylized facts. Our paper thus combines a theoretical analysis of two-sector models and a successful confrontation to data. In the end, we solve several empirical puzzles previously associated with two-sector models driven by expectations.

The research process

The research process was pretty long. Combining a rigorous theoretical analysis of the model and a successful confrontation to the data was nos easy. A formal analysis implies that any change in the model must be associated with a complete recalculation of the local stability properties! At the same time, introducing sufficient degrees of freedom in the model's specification was a key ingredient to improve the empirical results compared to the previous literature. Thus, it took us some time to obtain a convergence between these two steps. But in the end, it was worthwhile and we are very satisfied with the results!

Future research

We have developed tools that enable us to get the most of this mix between theoretical analysis and confrontation to data. These tools can be applied to a large set of models. We are now planning to continue improving the predictions of expectation-driven stochastic growth model by using more challenging data confrontation strategies such as direct matching of impulse response functions, Bayesian estimation, etc. Our aim is to progressively raise the standards imposed on such models in their ability to account for observed business cycles, and to make them more and more competing as an alternative explanation to models in which economic fluctuations are entirely driven by exogenous shocks on economic fundamentals.

5.2) Seminars


6.1) Overview

The EcAMSE project aims at developing in Aix-Marseille University the Ecole AMSE, a department of the FEG, Faculty of Economics and Management, providing world-class programs in Economics, Econometrics, and Finance, and delivering Magistère, Master and PhD diplomas.

Our project was awarded an Excellence Academy label by A*Midex in February 2015. A*Midex is a foundation of Aix Marseille University, managing a large grant aimed at fostering academic excellence in teaching and research. An Excellence Academy aims at combining advantages of the Universities and French Grandes Écoles. 


6.2) The Master AMSE

Conference in honour of Hervé Moulin September 17-18, 2015

Hervé Moulin, who is turning 65 this year, is one of the most prolific and original researchers in game theory and social choice. He graduated from Ecole Normale Supérieure in maths and started his career in Paris at the Laboratoire d'Econométrie de l'Ecole Polytechnique and the University Paris-Dauphine. He later moved to the United States, where he held professorships at Virginia tech, Duke and Rice University, and is currently the Donald J. Robertson Chair of Economics at the Adam Smith Business School at the University of Glasgow. Early in his career, he published one of the first books on game theory, which became a source of inspiration for many generations of researchers. He later published classical books on allocation and cost sharing problems and strategic aspects of social choice. Hervé Moulin published seminal articles on public good provision, mechanism design, assignment mechanisms and sharing rules. He also has applied interests on computational mechanism design and the practical implementation of mechanisms and sharing rules.
