Foreword

Dear readers,

2021 was the fourth year in operation for the Graduate School of Research (GSR) AMSE and, despite the ongoing Covid crisis and the multiple partial lockdowns, we made huge efforts to get back to “normal”. Above all, we tried as far as possible to ensure face-to-face teaching for our students, while naturally respecting all the safety rules. Building on our strong investments in high-level audio/video equipment in 2020, we were able to propose hybrid courses that offered many students the opportunity to be physically present while allowing those unable to be present for any reason to connect to the course online. All our seminars operated on this basis too, enabling us to maintain strong connections between all the members of the AMSE community and foreign researchers who collaborate with our team. We also launched our Diploma of Advanced University Studies (DESU) on Data Science for professionals, welcoming the first cohort of trainees registered for this new diploma offered under continuing education.

On the research side, two great efforts were made to restart “normal” activities. In particular, despite the pandemic hovering in the background, no “zero risk” policy was applied to events that brought groups of people together. All the conferences we organized had a hybrid format. The most important one, the 20th edition of the LAGV, was organized with both in person and online participants at the beautiful venue Palais du Pharo in Marseille. All our national and international attendees were extremely happy to attend one of the few face-to-face conferences of that period!

We also welcomed two new researchers: Romain Ferrali and Mathieu Lefebvre, working respectively on political economics and public economics. Their joining us will help develop various facets of our EUR program of research centered on a world undergoing crises.

On the outreach side, our bilingual review *Dialogues économiques* now exists both online and in print. The paper format is expected once a year and to contain all the articles published online during the previous year. The first issue contains articles from 2019 and 2020. This new format makes our review available in high schools, preparatory classes for the French *grandes écoles*, and university libraries, allowing our contributions to reach new audiences. On top of communicating the results of our research to a wider readership, this paper format should attract more students to our Master program. This strategy is complemented by the increasing number of our conferences and courses available as videos on our Youtube channel.

Aix-Marseille School of Economics combines a research unit (UMR 7316), a graduate school, and an outreach department.

Innovative and original, AMSE is centered on the fundamental concerns of our societies. Research and teaching are carefully combined to train a new generation of economists capable of dealing with all the challenges of a world in crisis, capable of putting their knowledge of economics to work for citizens and policy makers.

Under the EUR program, AMSE is receiving financial support for 10 years to carry out its three missions and become a center of excellence in economics in France and abroad.

Launched in 2011, AMSE brings together research and postgraduate studies in economics within AMU around a project on globalization and public policy.

The creation of AMSE enabled us to adapt to academic globalization and become a leading research center within the global community of economics departments.

AMSE brings together practically all of Aix-en-Provence and Marseille's economists within a single research department sharing a common vision of research and training.

The AMSE School (EcAMSE) was created in 2015 as a School of Economics within the University. It has been awarded the Academy of Excellence label by A*MIDEX.

The EUR program incorporates research and training governance to implement an innovative economics department, which combines the strengths of a university (academic excellence) and a French *Grande École* (shared perspective, close follow-up).

Research

AMSE research takes three directions, all related to the training offered by our graduate school:

- Economic crises and the crisis of macroeconomics.
- Development, democratic transitions, migrations, and growth.
- Facing environmental and health crises.

To explore these questions, we use our methodological expertise in dynamic and quantitative analyses, network theory, econometrics of time series-panel data, and big data.

Studies

AMSE trains economists to master both the tools of economic analysis and statistics. We provide world-class programs in Economics, focusing on empirical and theoretical economics, economic policy analysis, quantitative finance and insurance, and econometrics-big data-statistics. AMSE awards the following degrees: Master Economics, DESU Magistère Ingénieur Économiste, DESU Data science for executives, and PhD. Doctoral and post-doctoral training is based on applications and/or calls for projects. AMSE graduate school combines the advantages of the university and the French *Grandes École.s*.

Sharing

Sharing is the new name of our department in charge of outreach. It plays an essential role in disseminating knowledge. AMSE publishes an outreach e-review, called *Dialogues économiques*, on an independent bilingual website. In partnership with the Rectorat d'Aix-Marseille, AMSE offers lectures by researchers to secondary school students in their final year and those preparing for the French *Grandes Écoles* entrance exams.

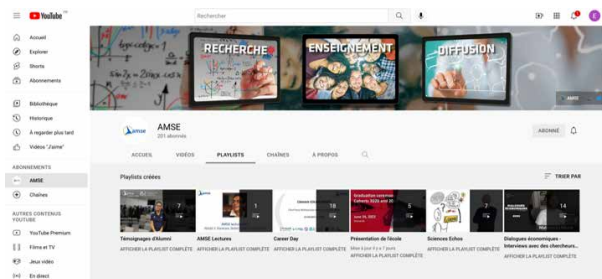

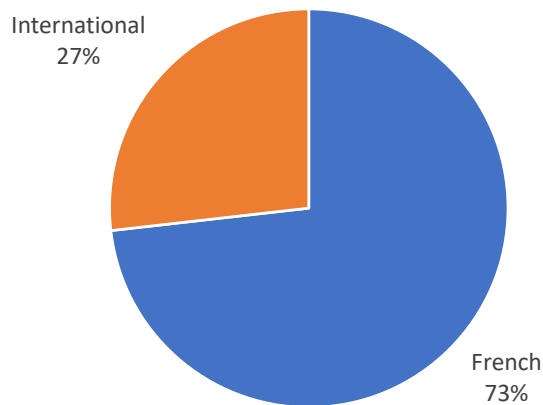

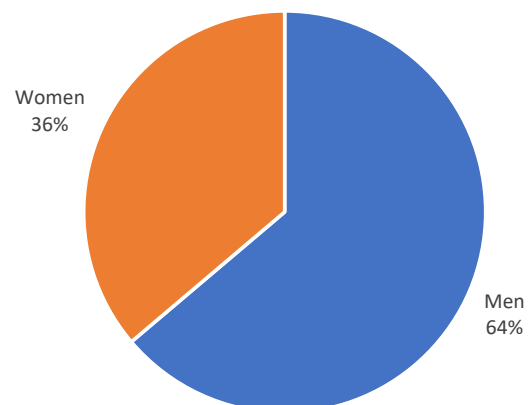
Nationalities of members

Researchers, Post-Doc, PhD and staff

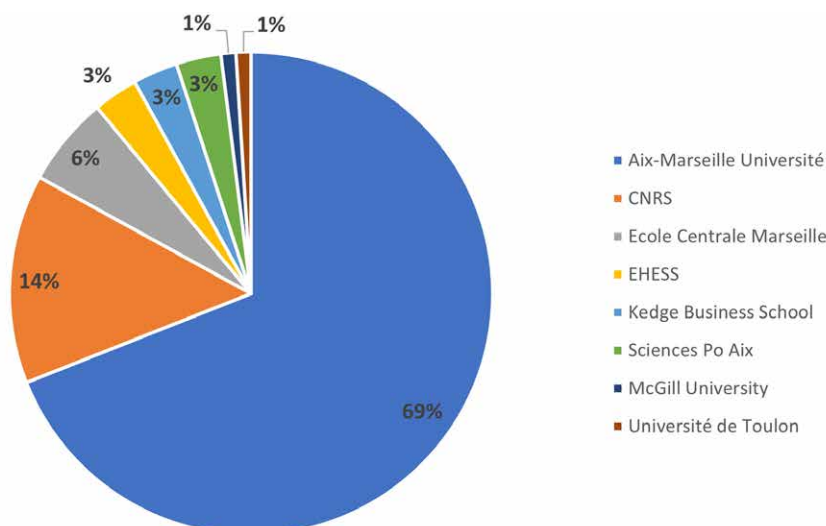


Women and men

Director of Innovation, Occupation, and Organization of the Regional Association for the Integration of People with Disabilities (ARI)

An excerpt from the portrait issued in the AMSE newsletter n° 13 - Interview done by Aurore Basiuk and Léa Dispa



CAN YOU DESCRIBE YOUR PROFESSIONAL TRAJECTORY SINCE YOUR TIME AT AMSE?

I completed my thesis in 2016 in health economics, under the supervision of Alain Paraponaris and Bruno Ventelou. In it, I explored “decisions on the labor market in a context of both economic and health uncertainty for people diagnosed with diseases and more particularly for self-employed workers diagnosed with cancer”, focusing on risk aversion and financial decisions. During my time at AMSE, I also had the opportunity to participate in an exchange study program at the Harvard School of Public Health. I was able to work there with James K. Hammitt, a renowned researcher on decision theory. I really enjoyed the research aspect of my thesis, but afterwards, being a pretty active person, I needed change. So I went to work in the corporate realm, where I ended up doing data analysis in the pharmaceutical industry. This experience put me up against different challenges and introduced me to a completely new way of working. I worked in the Market Access department for the American biotechnology company Amgen, which primarily engineers innovations in oncology and then for a consulting firm named Stratégique Santé, later purchased by IQVIA, a major private player in health-care data collection. My two main functions included collecting data for clinical trials and observational studies (such as efficacy and side effects) and negotiating drug prices with health authorities, based on budget impact production models as well as cost efficiency, cost effectiveness, and cost utility analyses. I have now been working for three years as Director of Innovation, Occupation, and Organization for ARI, a sociomedical organization in Provence-Alpes-Côte d’Azur. I also continue to teach, which I started to do during my PhD. This allows me to give something back to the universities that shaped me and it is always a pleasure to interact with students, who will be the future decision-makers. I still teach graduate-level courses in Public Policy Analysis at AMSE, and now I also teach Medical and Social Management at the University of Paris-Dauphine.

WHAT ARE YOU WORKING ON CURRENTLY?

ARI manages fifty structures that support children and adults with disabilities. Part of my work includes seeking out medical innovations, negotiating their prices, and helping teams use these innovations. I’m also working on developing research and science within ARI. When I arrived, I realized that there was little research on disability. This makes the provision of care particularly problematic, since the absence of research leaves quite a bit of room for subjectivity. As a response, we implemented the “Years of Science” program. Every couple of years, people with disabilities, families, and professionals come together to work on a specific scientific subject. Our first edition, for example, focused on neuroplasticity. Local and national researchers were invited to participate in related conferences. Afterwards, professionals, people with disabilities, and families met in working groups to collectively assess the organization’s current practices. This then led to an action plan being voted on; I now oversee the plan’s implementation and ensure that it is sustainable. But when it comes to research, there are to this day very few exhaustive databases on, for instance, the number of children with disabilities at school or on certain disabilities. Furthermore, there are only a small number of studies on informal care for people with disabilities and its economic cost. Yet, I am sure that the hidden economic cost is huge. The same applies to the impact of covid19 on people with disabilities: more research on this will be needed to understand what happened and to guide future policies. There is a lot to explore at the economic level and in terms of social justice, the stakes are also immense. So, I am launching an appeal : we need researchers in this field!



HOW DO YOU FEEL ABOUT YOUR TIME AT AMSE?

I'm a bit nostalgic about my time at AMSE. I miss having time to read, delve into a topic, explore an issue, and go to conferences and seminars to hear about others' research and to defend yours and your intellectual approach...what a luxury! PhD students in France are still discriminated against when they leave their research environment. So the pharmaceutical industry was a completely different world for me. I may not have been fully prepared when it came to understanding how companies function, manage, recognize, reward, and communicate; I had to learn on the job. That said, my strongest asset is what I learned during my thesis. Whatever the subject, I immediately know where to find the necessary expertise, and I have no problem reading and exploring a subject in depth to establish arguments based on rigorous analysis. Economics furthermore taught me to consider things from both a macro and a micro perspective; this helps enormously with strategic thinking. During my thesis, I learned how to manage a project—yes, doing a thesis basically comes down to managing a project from A to Z! I also learned how to go out into the field, how to observe and interview people so as to understand what they do and why, and to “get my hands dirty.” Being able to teach is also an asset. You learn how to speak in public, how to deliver messages. When I have to facilitate workshops with young people with behavioral problems or workers with disabilities, it really helps. Finally, one of AMSE's greatest strengths is the teaching staff's in-depth knowledge, particularly in mathematics and statistics. The teaching is not just based on simply learning a formula by heart. At AMSE, they go through the mathematical demonstrations to explain where the models come from – and that's worth a lot.

On the 81 articles, 60 were published in economics and 21 in other disciplines such as mathematics, philosophy, and medicine.

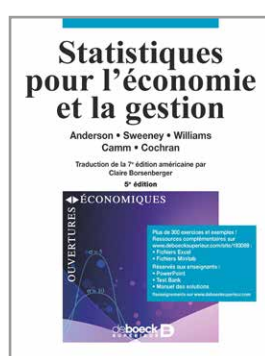

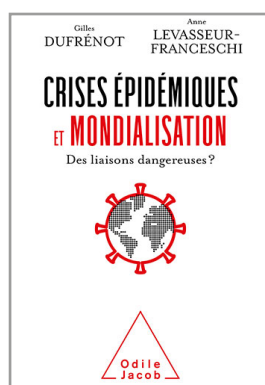

Reducing inequalities among unequals

Mathieu Faure & Nicolas Gravel, 2021, *International Economic Review*, vol. 62(1), 357-404.

Mathieu Faure has been a *Maître de conférence* at AMSE since 2011. He obtained his PhD in probability theory in 2002 at the university of Marne-la-Vallée. He was a postdoctoral fellow at the mathematical institute of Neuchâtel, Switzerland in 2008 and 2010, and at the department of Evolution and Ecology at the University of California, Davis in 2009.

Nicolas Gravel obtained a PhD in economics at the University of British Columbia in 1993. Before joining GREQAM as a full professor in 2000, he was a research fellow at Université Catholique de Louvain, an assistant professor at Université de Sherbrooke and an assistant professor at Université de Cergy Pontoise. His recent research deals with inequality measurement and contributions to public goods.

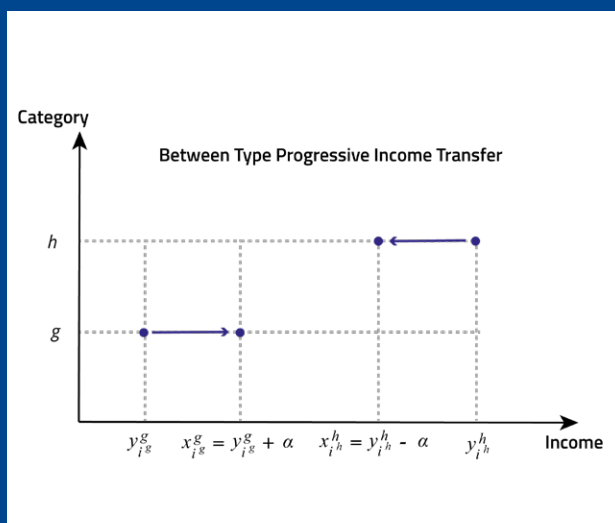
The Broader Research Program

A fundamental achievement of the modern theory of inequality measurement is the early demonstration by the mathematicians Hardy, Littlewood and Polya that four seemingly different definitions of «undisputable equalization» are actually equivalent. The first definition is the well-known principle of Pigou-Dalton transfers. The second definition is more ethical in nature and requires consensus among all inequality-averse welfarist ethical observers who assume that agents transform income into well-being by the same increasing and concave function. The third and fourth definitions provide empirically implementable tests. One of the two tests is Lorenz dominance, while the other is poverty reduction for all poverty lines, with poverty measured by the minimum income required to eliminate poverty with respect to the line. While this equivalence is foundational to inequality measurement, it only concerns distributions of one cardinally measurable attribute – such as income – between otherwise homogeneous agents. Yet income is not the only relevant source of differentiation between economic agents. If these agents are communities such as households or jurisdictions, they differ not only in their total income but also in number of members. If the agents are individuals, they may also differ in characteristics such as age, health, education or effort. What does «undisputably reducing inequalities» in income mean when applied to agents who differ with respect to

another characteristic? This is the basic question addressed in this paper.

Paper's contributions

This paper establishes an equivalence between four definitions of «undisputable equalization» of income among agents vertically differentiated with respect to a non-income characteristic, each of these definitions being analogous in nature to the definitions for homogenous agents. The first definition is the possibility of going from one distribution to the other by a finite sequence of income transfers from richer and more highly ranked agents to poorer and less highly ranked ones. This can be seen as a weakening of the principle of Pigou-Dalton transfer, limiting its scope to agents who can be ordered both by their income and by the other characteristic. The second definition is that underlying a consensus among inequality-averse welfarist ethical observers who assume that all agents transform income into well-being by the same utility function, which is increasing and concave with respect to income only and whose marginal utility of income is decreasing with respect to the other characteristic. The third definition is similar to poverty reduction for all poverty lines, but with the poverty lines allowed to be a non-increasing function of the other characteristic. The intuition is that being poor in income is more difficult for a healthy person than for an otherwise identical person who is ill. The fourth definition is similar in spirit



to Lorenz dominance and views as «undisputably equalizing» any transformation in the income distributions that increases the total income of the k poorest agents, no matter what k is. However, it is not straightforward to define who these k -poorest agents are when the agents differ in another characteristic. Our paper provides such a definition and shows that it gives rise to a Lorenz-like criterion whose dominance is equivalent to the three other notions of equalization. Prior to this paper, attempts were made to examine the connections between some of the above definitions. However, no proof of the equivalence between the transfer-based notion of equalization and either the welfarist or the poverty criterion was ever obtained. An important contribution of this paper is to provide such a proof, one that has turned out to be rather challenging. The proof actually involved constructing an algorithm for going from a distribution y to a distribution x by a finite sequence of inequality-reducing transfers that is based solely on the information that x dominates y as per the ordered poverty gap criterion. Another important accomplishment of the paper is the discovery of a generalization of Lorenz dominance that can be used to compare distributions of incomes among vertically differentiated agents.

Future directions

There are at least three directions in which the analysis of this paper could be extended. One of them concerns applications of the implementable

dominance criteria characterized in our paper. Poverty dominance for all increasing poverty lines is a somewhat simple criterion that has not been used much in empirical analysis, even though some authors have shown that it is easily amenable to statistical inference techniques. It is our hope that the arguments we provide in its favour will encourage its use in empirical work. Another direction for future research would be to better appraise the performance of the two implementable criteria - poverty dominance and our new Lorenz-like dominance criterion - in terms of computational complexity. A third potential direction for future research would be to identify inequality indices compatible with the incomplete ranking of distributions that we have characterized.



Air pollution in an urban world: A global view on density, cities and emissions

Research program

Population growth and global warming are two of the most pressing challenges that humanity faces in the 21st century. Increasing populations and ongoing urbanization are leading to larger and, in many cases, denser cities. One alarming side effect of urban life is air pollution, which has serious consequences on human capital, productivity and health.

The evolution of emissions per capita, together with the population density-emissions relationship, is not straightforward and is likely to depend on several factors, including income levels and demand patterns, productive technologies, and infrastructures. Conceptually, one can distinguish the Malthusian (1798) from the Boserupian (1981) view: according to the first theory, population growth overexploits resources and raises emissions per capita. By contrast, the second holds that a growing population, due to agglomeration externalities, fosters innovation, for example in agricultural technology and energy-saving. Therefore, changes in the spatial distribution of population and economic activity are likely to play a decisive role in how emissions per capita evolve.

To study the effects of density and the spatial distribution of population on emissions, we build i) a large and unique dataset for more than 1200 (big) cities around the world with data for the last two decades, and ii) a large dataset for more than 190 countries with data from 1960 to 2010. We

combine data from several sources, including air quality stations around the world (CO₂ and PM_{2.5} for robustness), national and international statistics, and satellite imagery. In particular, we use city-level data from the European Commission's Global Human Settlement Layers (GHSL) from the Urban Centre Database and different measures of the urban form for our 1234 cities based on satellite data on night-time lights, as illustrated in Figure 1.

The two pictures present maps of Paris and Medellín (Colombia), illustrating the distribution of night-time lights across the pixels of the built-up area. Night-time lights in 2013 are depicted with respect to each city's maximum luminosity, with brighter colors (yellow, orange, red) denoting higher values and darker colors (purple, black) lower values. The urban areas of the city based on GHSL data for 2015 form the backdrop. Paris shows strong monocentricity (Moran's I of 0.9502) while Medellín (Moran's I of 0.7686) is rather fragmented.

We link and complement the insights obtained in our city-level analysis with an investigation at country level, paying special attention to a factor omitted from the literature to date, namely, density in urban areas. Population density in a country may differ substantially from density in urban areas. For example, Egypt has comparatively low population density overall, but very high population density in urban areas, driven by high density in its main cities such as Cairo.

Paper's contribution

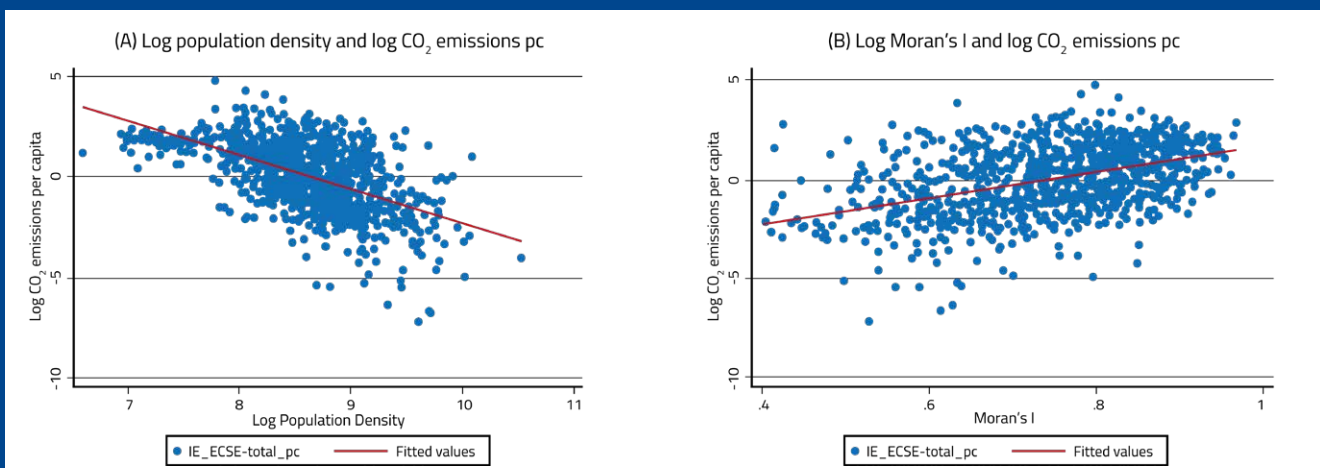


Figure 2. Scatter plots across 1328 cities for the year 2015

We document that denser cities show lower emissions per capita, as illustrated by Figure 2A. This negative relationship between city density and emissions per capita is robust to several controls, different estimation techniques and identification strategies. Using our global sample of cities, we also found evidence of the Environmental Kuznets Curve (EKC), suggesting that emissions per capita go up with income levels at early stages of development, but then decline as development proceeds. This is the first time that the EKC curve is reported in a global sample of cities.

Moreover, we find that the spatial structure of cities also plays an important role. On average, a monocentric (compact) city pollutes more than a polycentric (dispersed) one, and this is particularly true for large cities (Figure 2B). These results are consistent with the theoretical predictions of Denant-Boemont et al.

(2018), who propose a mechanism related to transport emissions.

Our results at city level are supported by new insights gained here at country level. While higher total population density and urbanization are associated with higher CO₂ emissions per capita, the opposite applies when we look at urban population density: higher density in urban areas is associated with lower emissions per capita.

In terms of policy implications, our results suggest that policy-makers concerned with pollution should pay attention not only to population dynamics but also to the evolution of the spatial distribution of population, both at country and at city level. Based on our results, fostering denser urban areas could lead to lower emissions per capita. Similarly, as cities grow, a more spatially decentralized (i.e., polycentric) structure should be encouraged.

Land is back, it should be taxed, it can be taxed

Alain Trannoy is a research professor at EHESS and a member of AMSE since 2002. He obtained his Doctorat d'Etat in 1986 from the University of Rennes 1, where he became a professor in 1988. He was also a professor at the University of Cergy-Pontoise from 1991 to 2002.

Research program

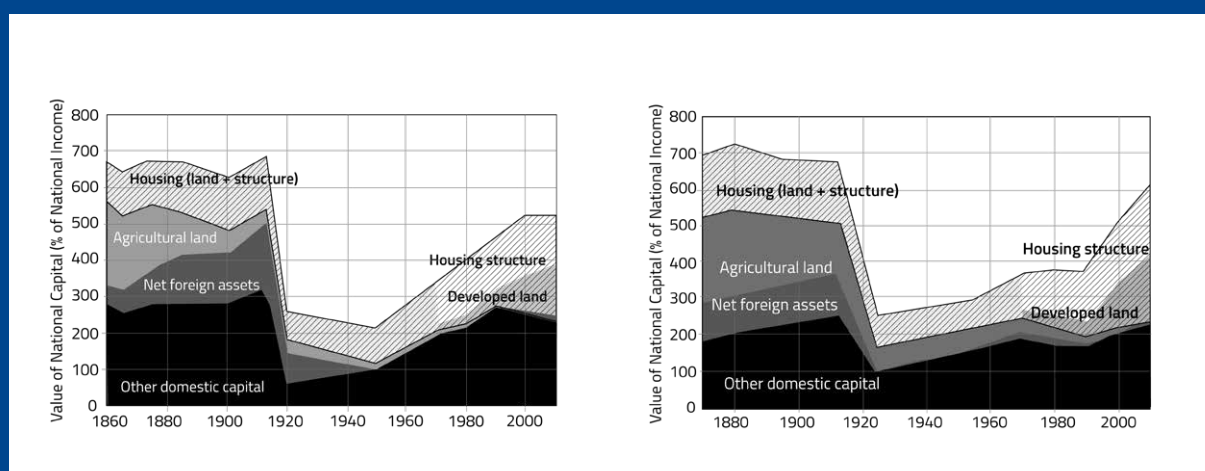


Figure 1. The role of land and housing in the secular variations in the wealth-to-income ratio. France and UK

Uniform taxation of wealth is making a comeback as a response to rising public debt and increased inequality in most Western countries. This paper enters this debate from the striking observation that the housing component of national private wealth explains the spectacular rise of wealth relative to national income in several countries. Rising housing wealth is in major part due to the rise in land prices. Figure 1 represents the historical evolution of wealth-to-income ratios in France and the UK, using Piketty's decomposition into housing, agricultural land, net foreign assets and other domestic assets.

The drop in total wealth at the beginning of the 20th century as compared to the 19th century was largely due to the secular decline in agricultural land and was accelerated by the decline in physical capital after WWI in France and the UK. If wealth levels rose again in the second half of the 20th century and partially regained their values of the previous century, it is because housing became a major component of wealth. Given the heterogeneity in sources of wealth and their diverging trends, applying one uniform wealth tax could be sub-optimal, especially considering the differences in supply elasticities. We assess the merits of differentiated taxation of wealth and compare land taxation, housing income taxation and physical capital taxes.

Paper's contributions

We extend a Judd-type model of capitalists and workers, an appropriate framework to study redistributive capital taxation, by introducing land, housing structures, housing consumption and the housing rental market. Actually, the Judd-Chamley framework represents a turning point in the literature discussing capital and wealth taxation issues. The literature has explored certain tax areas: e.g. taxes on labor and capital income, labor and dividends, or taxes on consumption, labor and pure rents. In this paper, we turn a new corner, exploring taxes on capital, land and housing and thus contributing to the literature by widening the scope. We perform this analysis both in first-best and second-best settings, under full commitment.

A uniform land tax is theoretically enough to achieve the first best. We discuss cases and levels at which land taxes are feasible, and notably propose a formula for a property tax on land that will reach the social planner's objective. This tax will compensate wage-earners for having no property rights on capital and land. When land can actually be taxed at the first-best level, taxing productive capital is not necessary. The quantitative and theoretical importance of a fixed factor, land, is reminiscent of the so-called Georgist view.

However, taxing land raises implementation issues and is seldom put into practice. Furthermore, land is difficult to distinguish from housing structures

that are themselves elastic, and in order to reach the first best, static and dynamic distortions must be addressed. Therefore, we consider richer schemes that may and actually do preserve the first best. Indirect land taxation via the taxation of housing income is possible, but it cannot be implemented alone to reach the first best. A tax on rent therefore needs to be supplemented by i) a tax on land differentiated according to use of land - less on rented land and more on owner-occupied land - and ii) a specific subsidy on investments in rented structures. Without this specific combination of tax/subsidies, the first best cannot be achieved. However, based on the two distortions introduced by the tax on rent, one to land use and the other to the dynamics of the structures, our simulation reveals that the latter is much more critical quantitatively.

The upshot is that a rent tax supplemented by a structure subsidy does almost as well as a land tax in improving social welfare. The discussion illustrates the non-triviality of a tax scheme attempting to overcome the non-feasibility of an optimal uniform land tax. This set of instruments provides a rare example of the usefulness of the theory of the second best (Lipsey – Lancaster), combining three distortive instruments to mimic the impact of a non-distortive instrument.

Adopting a second-best Ramsey logic, where the social planner acts under the rationality constraints of agents, we next assume that a

land tax is not feasible but that there is a rent tax. We then explore how the results in the steady state extend on dynamic convergent paths to the steady state. We obtain new results regarding the dynamics of capital taxes in the Judd economy with and without land, as well as results on the rent tax when it can be introduced.

Future research

A follow-up to this article is a book in French, written with Etienne Wasmer, published in January 2022 and possibly followed by an English translation (*Le Grand retour de la terre dans les patrimoines : et pourquoi c'est une bonne nouvelle!* Alain Trannoy and Étienne Wasmer, 2022-01-19, 256 pages, Odile Jacob, 2022).

Despite Covid, this LAGV offer 280 papers selected from the proposals submitted.

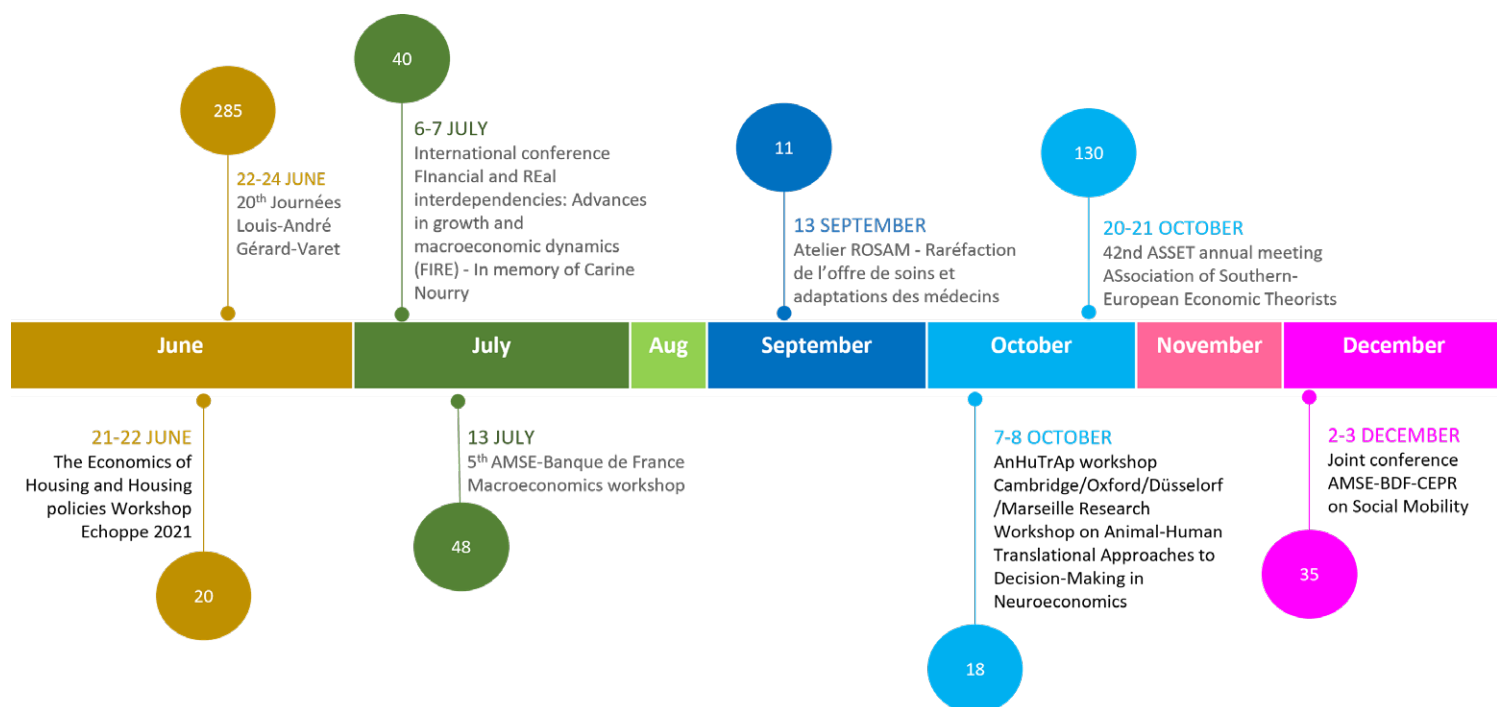

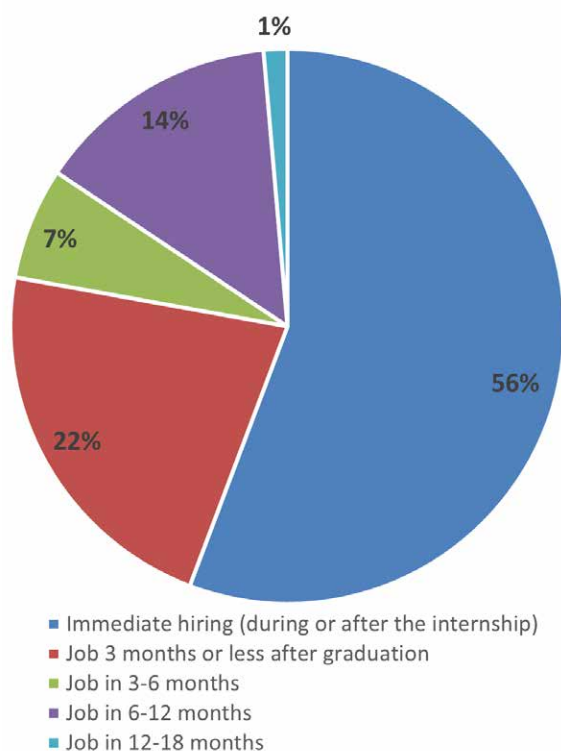

M2 EBDS track of the Master's in Economics open to apprenticeships in 2021

Apprenticeship allows students to continue their studies and learn a trade, alternating between university and a company, under dual student and employee status. It is available to students who wish to pursue a degree while acquiring professional experience.

The M2 Econometrics, Big Data, Statistics (EBDS) track of the Master's in Economics has been open to apprenticeships since September 2021. Apprenticeship was chosen by nearly 30% of the students enrolled in this track. Using apprenticeship to meet professional objectives is a key motivation for students:

Apprenticeship is a form of education that is increasingly in demand by students, especially those with a specific career plan. Thanks to

apprenticeship, students can get a foot in the real world, as they call it, without getting left behind by the school.

AMSE pays close attention to the follow-up of its apprenticeship students. Apprentices receive dual supervision throughout their master: that of the company's apprenticeship supervisor and that of a university tutor.

The university tutor, appointed from among the AMSE teachers, ensures that the apprenticeship runs smoothly throughout the academic year and that the internship report is completed. The tutor also makes two visits to the company.

As Head of Apprenticeship, my mission is to supervise students who choose to do an apprenticeship. Working closely with the apprentice training centre (CFA), I ensure that the apprenticeship contracts are signed and that the tools for monitoring the apprentice are put in place. I also ensure that university tutors are appointed. Throughout the year, I act as an interface between the students, the CFA and the company, and also help apprentices find a company”.

International connections

The Master's program has greatly developed its relations with foreign universities, enabling one third of M1 students to spend a semester abroad. Concurrently, double degrees allow students to spend a full year in mobility. AMSE undertook two new double degrees with the University of Tübingen and with the Católica Lisbon School of Business and Economics. The dual degree with Konstanz started in 2019 and has involved 18 students so far. The double degree with Tübingen started in 2021 and with 1 outgoing student and 6 incoming students are expected in September 2022. The dual degree with Católica Lisbon started in 2021 with 3 outgoing students.

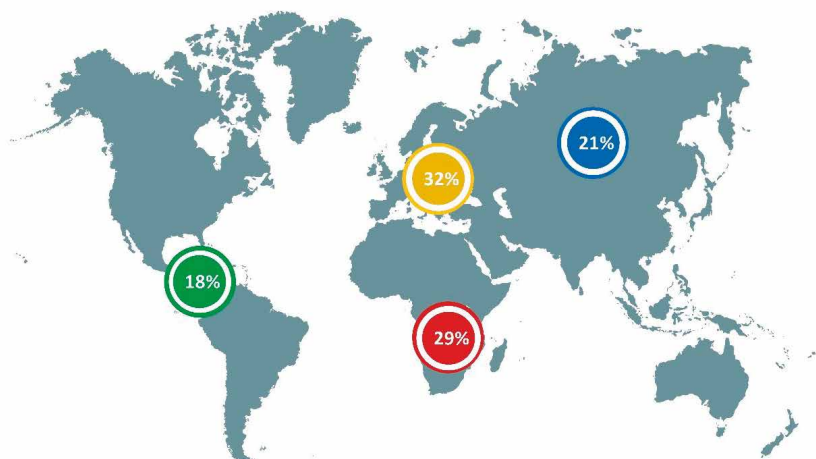
Happy to host incoming students

AMSE is pleased to host many international students from all over the world. Looking beyond the quality of the programs of studies, international students are attracted to study at AMSE by a true English-speaking environment (Master 1 taught in both French and English, Master 2 entirely taught in English), a window on the world, and multiculturalism.

Geographical distribution of incoming students

Incoming mobility is a fact of life at AMSE. Over the last three years, we have welcomed an average of 44% international students (in both master and magistère programmes). More than 33 different nationalities have been represented in our year classes, on average, since 2018. Despite the uncertainties due to the COVID-19 pandemic, incoming mobility has not been negatively impacted, and AMSE continues to make the most of its specific strengths.

Scholarships program

Each year AMSE offers around ten scholarships to incoming students. Over the last three years, AMSE has awarded 140 K€ in scholarships. These scholarships go to students obtaining top grades the years before they enter our programs. Over the past three years, AMSE has also welcomed 6 students on the prestigious Eiffel scholarship program; demonstrating the high level of our candidates and our commitment to developing an international policy of excellence.

University degree in Data science for professionals

2021 saw the first cohort of trainees enrolled in this new diploma offered under continuing education. Based on its experience in initial training in Big Data, AMSE offers a short program of 10 training modules in Data Science for professionals. 23 days spread over 3 months and a Diploma of Advanced University Studies (DESU) delivered by Aix-Marseille University at the end!

PhD program

The PhD program expanded and restructured its curriculum. The number of courses has increased, relying on both internal and visiting faculty. Courses are now organized in three modules: "topics in economics" – advanced courses in economics –, "Methods" – courses in advanced applied methods, with a focus on big data –, and "Professionalizing courses" – providing PhD candidates with practical training in job-market oriented skills (presenting skills, academic practices, etc.). These modules are complemented by reading groups where PhD students present and discuss recent frontier research.

With travel restrictions lifted, mobility resumed and AMSE PhD could progressively go back to research visits to top international universities in Europe and the US (for instance University of Bocconi, University Pompeu Fabra, or Indiana University).

The AMSE PhD Program continued its one-year fellowships for external PhD candidates close to completion. Three PhD candidates from the Paris School of Economics, Warwick and the European University Institute spent the academic year on the AMSE premises, completing their thesis and interacting with the AMSE PhD students and faculty. One of them was offered a post-doctoral fellowship and will therefore continue working at AMSE.

The PhD placement office also continued to prepare candidates for entering the job market by organizing training sessions, mock interviews, and mock seminars. They provided additional support to PhD (and postdoctoral) candidates by following their progress and contacting potential recruiters.

An innovation was to record and post on the AMSE website short videos of job market papers, to further attract attention to AMSE job market candidates. PhD candidates secured academic positions in France, the UK, Luxembourg, positions in international organizations such as the IMF, the European Commission, or Banque de France, and private sector jobs as economist, data scientist or statisticians.

Summer school on "The Economics of networks"

The AMSE Summer School of July 2021 covered recent theories and empirical approaches designed by economists to study complex interactions within networks of individuals, firms, and governments.

Networks permeate our daily lives. Individuals learn about new products and job opportunities through family, friends, neighbors and colleagues. Firms' choice of technology is heavily influenced by spillovers from nearby firms and competitors. Governments' policies are shaped by international alliances and institutions. In these examples, the behaviour of agents (individuals, firms and governments) affects other agents, whose response might affect other agents, and so on. Economists study how these interactions develop through complex networks and have profound effects in different areas - labor markets, competition among firms, political beliefs and outcomes, to name a few.

The three days of the Summer School gave students rigorous and in-depth exposure to the most recent theories and empirical methods in the economics of networks. Lectures were given by leading experts in the field: Lori Beaman (Northwestern University), Sanjeev Goyal (University of Cambridge), Yann Bramoullé (CNRS, AMSE) and Habiba Djebbari (Aix-Marseille University, AMSE).

Attended by PhD students from all over the world the summer school also introduced participants to Marseille, its surroundings, and its islands!



Students involved

195 students in the MA in Economics

At the start of the 2021/2022 academic year, 195 students were registered in the MA Economics: 94 in first year and 101 in second year.

Of the M2 students, 18 are in the research track Empirical and theoretical economics. The rest are in the three other M2 tracks: Economic policy analysis, Quantitative finance and insurance, and Econometrics-big data-statistics.

93 students in the Magistère ingénieur économiste

At the start of the 2021/2022 academic year, 93 students were registered in this program: 31 in first year, 36 in second year and 26 in third year. Second and third-year students are also registered in the Master Economics.

Overall 51,3% of our MA and Magistère students were international in 2021, coming from around the world.

If 2021 remains afflicted by COVID, it is also that of a gradual return to normal. It also stands out as the year of the launch of the AMSE YouTube channel. After a discreet creation in 2020 during the first lockdown, this channel hosted around thirty videos at the end of 2021.

Sharing

Our communication tools were refined and enriched, with an objective that remained unchanged: to create a sustainable and effective interface between science and society.

Dialogues Economiques

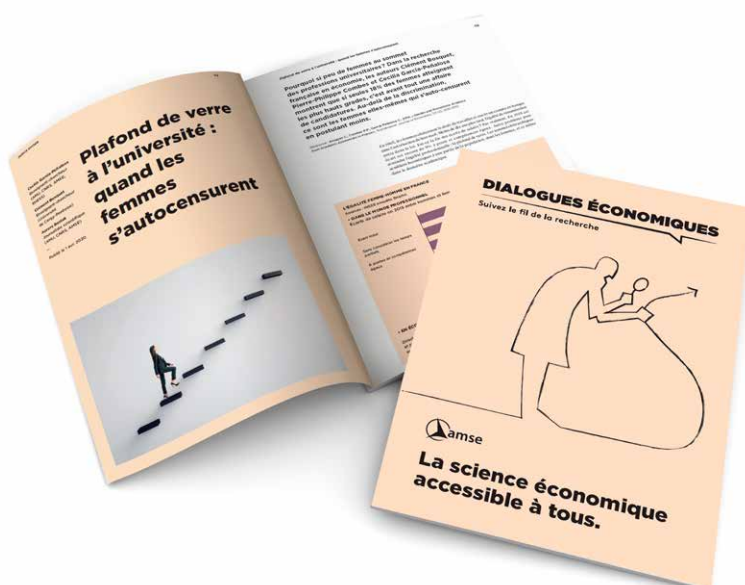
Dialogues Économiques now appears both an online and in print. The first print issue contains articles from 2019 and 2020 and a second one is in preparation. This new format means the articles now reach new audiences in high school, preparatory classes to French *grandes écoles*, and university libraries.

The online version is still our main medium and continues its mission to make Economics accessible for all with a total of 73 articles in French and English. Since its launch in 2019, its audience has continued to grow, reaching a record 24817 page-views in 2021.

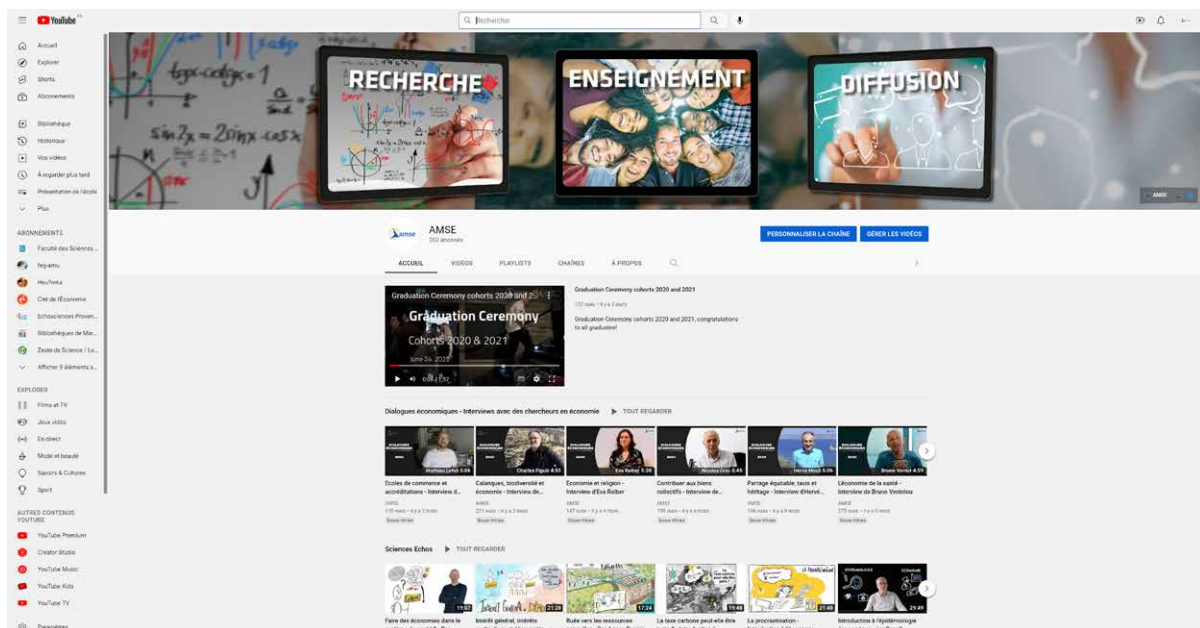

Sciences Echos

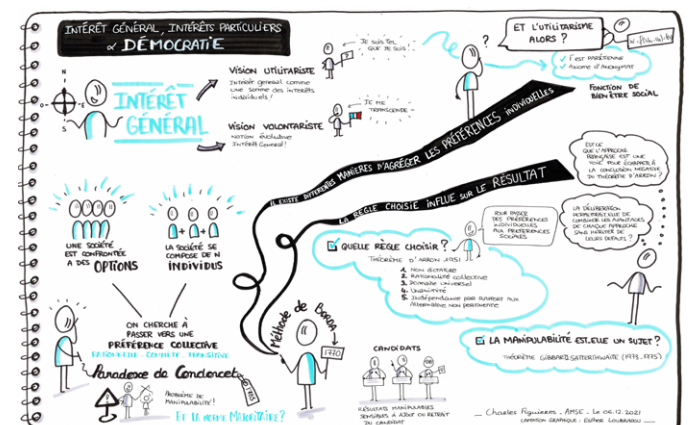

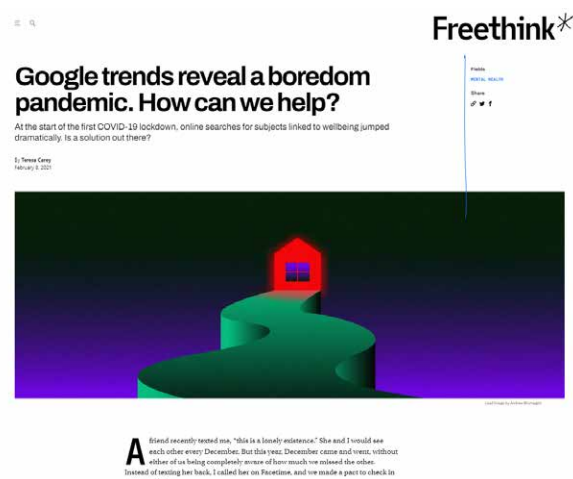

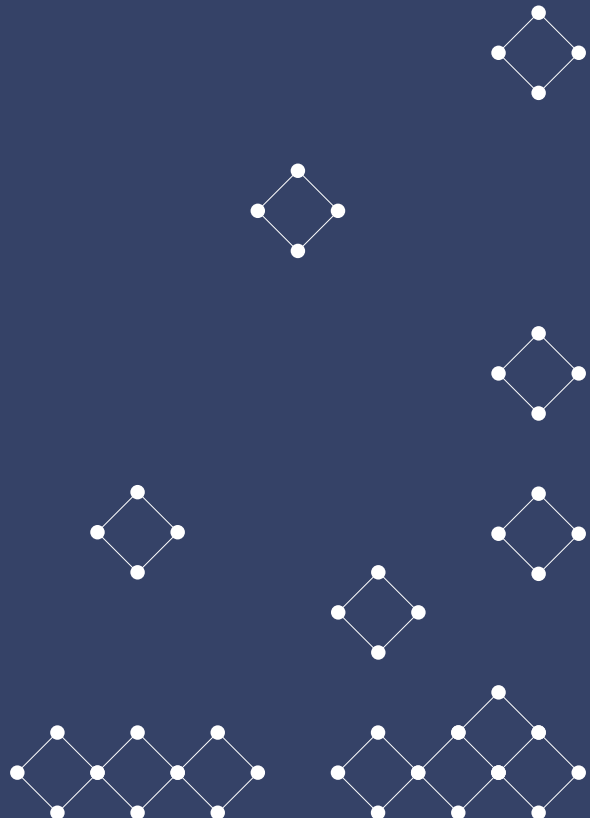
