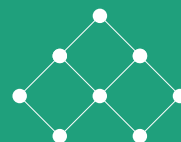

# Foreword

## Dear readers,

2024 was the seventh year in operation for the Graduate School of Research (GSR) AMSE. After our successful mid-term evaluation that has led to the recognition of the quality of the collective work accomplished by AMSE in terms of research, teaching, and the dissemination of knowledge, and with our plans for the next five years approved, securing our future post-GSR funding became crucial.

The first step has been taken: AMSE has been awarded the label "Institut d'Etablissement" of Aix-Marseille University. This prestigious label acknowledges our position at the intersection of research and education. Officially taking effect from January 2028, it will further enhance our national and international visibility and strengthen our interdisciplinary approach. We can be proud of this recognition collectively. It also confirms our full integration into AMU's scientific policy and opens the way to extended financial support from AMIDEX after the end of the GSR program in 2028. Working on securing this funding, together with seeking to attract external financial support, will be the main task of the remaining three years.

On the education side, September 2024 saw the launch of our new Master's program with three tracks leading to three distinct master's degrees: "Econometrics and Statistics", "Economics" and "Finance". The Master in "Economics" notably offers in M2 the track "Data, Analysis, Decision and Economic Evaluation" (DADEE), which marks the beginning of a new collaboration with Sciences Po Aix. This complements the research links that have been developing with this prestigious institution since it became one of AMSE's partner institutions in 2023.

On the research side, in addition to all the policy lectures, seminars, workshops, and conferences regularly organized throughout the year, the 23rd edition of the LAGV in the outstanding Palais du Pharo in Marseille and the 5th AMSE Summer School on "Discounting, Risk, and the Environment" once again met with great success.

Our recruitment policy has also been very successful this year. Through our now regular "Newcomers Welcome Day", we had the pleasure of welcoming two professors, Guillaume Bazot, Quentin Lippman, three assistant professors, Pierre Bertrand, Ségal Le Guern Herry, Morgan Raux, and one CNRS research fellow, Arthur Guillouzouic. These recruits are developing new facets of research and teaching on macroeconomics, labor economics, public economics, experimental economics, game theory, and social networks. We also welcomed four new Post-Docs, Mohamed Bahlali, John Cremin, Amit Dekel, and Alexandros Loukas, who are expanding our expertise in environmental economics, game theory, macroeconomics, and social networks.

On the outreach side, we are proud to celebrate the 5th anniversary of our online bilingual review "Dialogues économiques" designed to introduce academic research in economics to the general public. In a world of major disruptions, the continuously increasing number of views it attracts clearly illustrates how society values economic insights, confirming the importance of the dissemination of knowledge strategy at the core of our GSR project. In response to Twitter's change in editorial policy, and consistent with its core values, AMSE made the decision to withdraw from the platform and transition to Bluesky. AMSE was once again been a leading partner in the 5th edition of the "Allez Savoir Social Sciences Festival" organized by EHESS and the City of Marseille.

# Overview

At AMSE, our mission is to advance knowledge through innovative research and to train future economists through high-quality teaching. We also aim to share this knowledge beyond the academic world, ensuring that our work contributes to society.

Our expertise is grounded in the variety and depth of the topics explored by our researchers. As part of the GSR program, we focus on key societal challenges, including:

- economic crises and the current rethinking of macroeconomic frameworks,
- development, democratic transitions, migration, and growth,
- environmental and health issues.

These themes are addressed using rigorous theoretical and empirical methods, reflecting AMSE's commitment to engaged and relevant research.

With the support of a ten-year grant through the GSR program, AMSE continues to develop its three core missions: research, education, and outreach, aiming to strengthen its position in the field of economics in France and internationally.

Founded in 2011, AMSE brought together research and postgraduate education in economics within Aix-Marseille Université. This initiative responded to the growing internationalization of academic standards and helped consolidate economics research within a unified structure.

Today, nearly all the economists from Aix-en-Provence and Marseille work together within AMSE, sharing a common approach to research and teaching. Since 2015, the AMSE School (EcAMSE) has served as the university's graduate school of economics. It was awarded the Academy of Excellence label by A\*MIDEX and combines academic standards with personalized mentoring and coherent program design.

Research and teaching are closely linked at AMSE. Our goal is to train economists who can contribute to public debate and inform decision-making in a world facing multiple challenges.

Since 2018, AMSE has adopted a governance model that encourages participation and coordination across its activities. This structure supports collaboration between research, education, and outreach.

In 2024, AMSE received the "*Institut d'établissement*" label from Aix-Marseille Université. This distinction reflects our ability to connect research and teaching, promote innovation, and further develop our strengths. It also reinforces our integration into AMU's scientific strategy and strengthens our role as a partner institution. This new status will help AMSE continue to develop its educational and research activities, support its community, and engage with wider social and economic networks. It is a valuable opportunity to pursue new directions and broaden our impact.

The objectives of this Institute will be to:

- (i) address issues of transition in contexts of risk and uncertainty, with a focus on health and environmental transitions, financial and digital transitions, and economic transitions towards more inclusive growth models,
- (ii) strengthen and give greater visibility to the interdisciplinary work already carried out by the laboratory's researchers while initiating new collaborations,
- (iii) promote the establishment of socio-economic partnerships at the local, national, and international levels,
- and (iv) respond to societal demands by shedding light on major societal issues and acting as an interface between academic research and the expectations of public decision-makers and private operators.

We expect this Institute label to contribute to building high-level scientific and educational communities at the local, national, and international levels, with a multidisciplinary focus and links to key societal challenges. It should also improve our ability to respond to national and European calls for tender and to obtain other sources of external funding.

## Financial situation

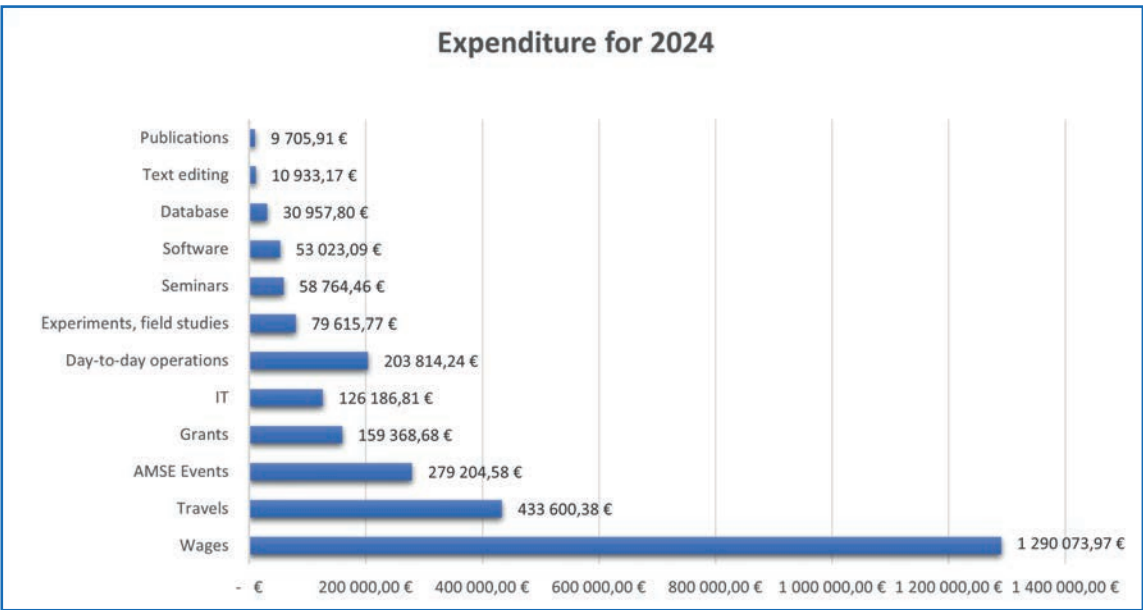
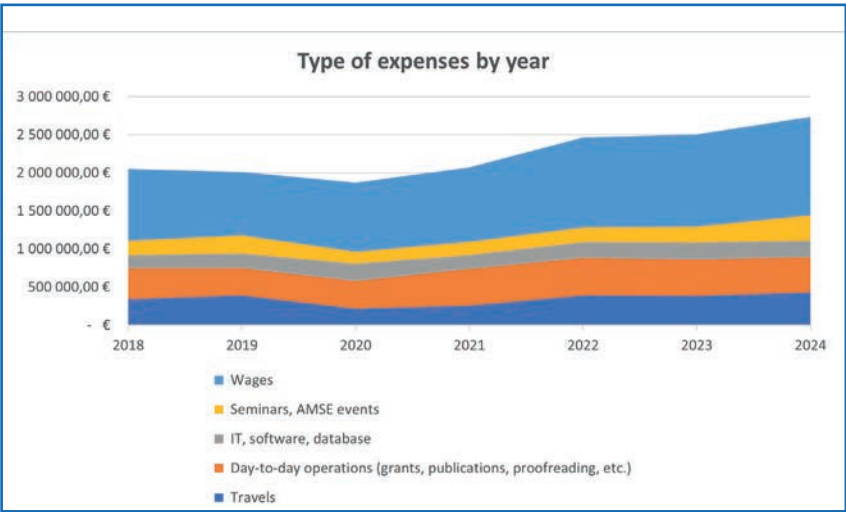
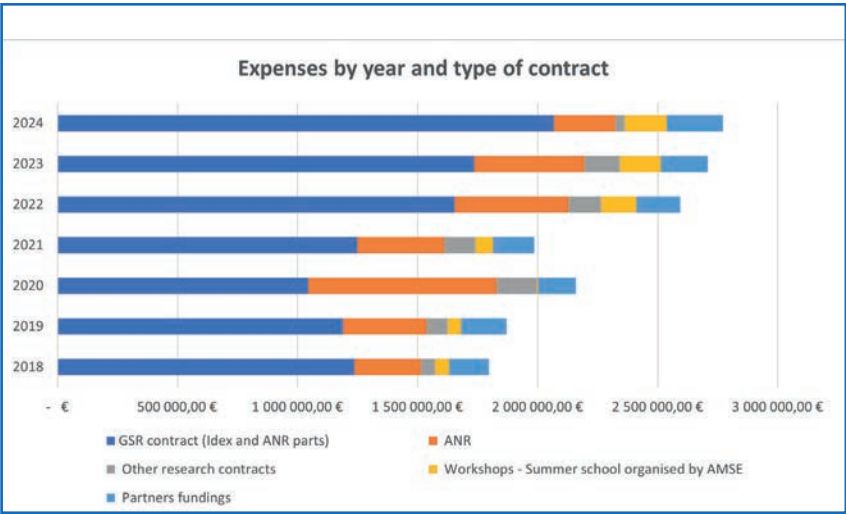
AMSE was awarded a GSR grant in 2017 during the first wave of such funding from PIA3.

This funding began in 2018 and was formalized by co-financing from ANR and AMIDEX over 10 years for a total of €16,662,000, with AMU's share of the grant representing 42.2%.

The financial support will continue until early 2028. It reflects our LABEX status and is aimed at ensuring the successful establishment of a "Graduate School" in economics at the Aix-Marseille site, based on three key activities: research, training through the School of Economics, and public outreach.

AMSE is also the recipient of a €937,000 donation from the Banque de France Foundation, to be used by 01/09/2032 to finance research activities in monetary, banking, and financial economics. These resources enable us to offer generous funding to contribute to the construction of the European Research Area (organization of major international and European conferences) and to provide excellent working conditions and financial support to all our members (PhD students, postdocs, researchers).

We also use these resources to finance our wide-ranging mediation and scientific promotion activities, as well as all the AMSE School activities outside the scope of the Faculty of Economics and Management (extra courses, graduation ceremony, career day, etc.).

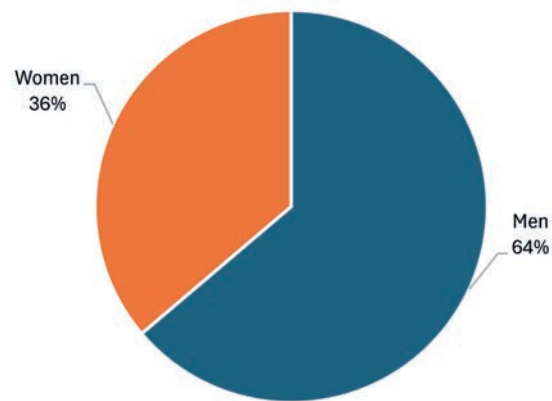

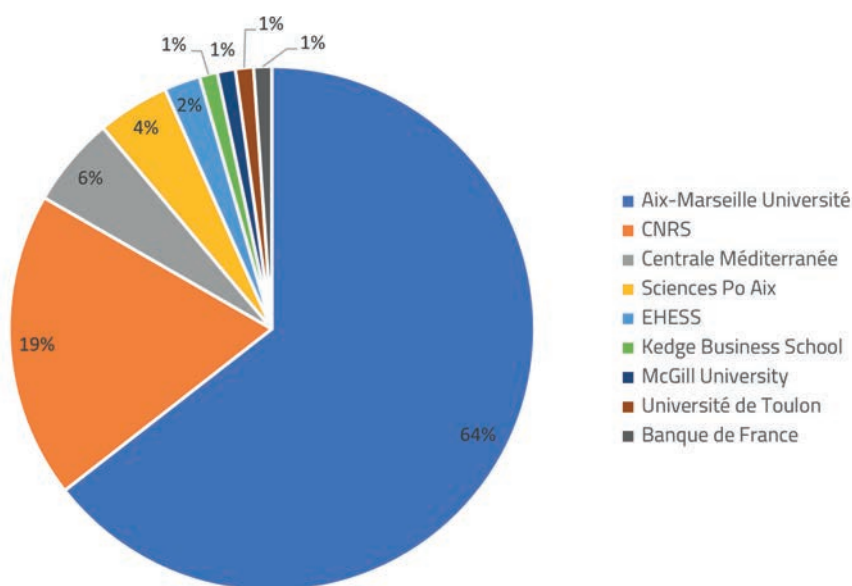

## Portrait

### Pavel Diev

Head of the International Monetary Relations Division at the Banque de France

Pavel Diev completed his thesis in 2007 at AMSE. At that time, he had already set out on his professional pathway within the Banque de France, where today he is Head of the International Monetary Relations Division.

### CAN YOU DESCRIBE YOUR CAREER TRAJECTORY SINCE YOUR TIME AT AMSE?

I completed my PhD in 2007, under the supervision of Christophe Deissenberg. My thesis focused on efficient mechanisms for the provision of public goods. This topic combined both game theory and experimental economics.

I joined the Banque de France two years earlier, in end-2005. I had anticipated the end of my thesis and started prospecting in the professional world, with a career as an economist in view.

My very first position at the Banque de France was as an international economist in the Macroeconomic Analysis and Forecasting Division. I was in charge of monitoring several countries, particularly in Eastern Europe - Czech Republic, Poland, Ukraine, Russia. In the mid-2000s, there were a lot of investments in these countries, and some were in the process of integrating into the European Union. There was a strong demand for monitoring of macroeconomic indicators to coordinate policies.

I quickly moved into management positions. I became Head of Unit and then Deputy Head of the European Relations Division. The European Relations Division prepares meetings attended by the Governor of the Banque de France. I started by working on the Governing Council, where political and monetary decisions are made, in Frankfurt.

The Governing Council is composed of all the Governors of the member countries of the euro area plus the members of the ECB's executive board in Frankfurt.

I was immersed in the decision-making mechanics of European monetary policy by preparing the Governor's positions. We briefed the Governor, prepared his talking points with the various experts from the Bank on the agenda topics, which change from meeting to meeting. A lot of meetings take place. What the public hears about are the «monetary councils», where interest rate and monetary policy decisions are made, often followed by a publicized press conference. But between these monetary councils, there are «non-monetary councils» about twice a month that make all the other budgetary or administrative decisions that are not visible to the general public.

I was also Head of the Conjunctural Analysis and Forecasting Division, from 2018 to 2022. This division deals with monitoring and forecasting macroeconomic variables for France. It was a real challenge to make economic forecasts during the health crisis! There were supply chain disruptions everywhere, a third of the economy was shut down, so we first had to predict the GDP drop. Regular statistical reports were disrupted, and we relied heavily on qualitative contacts within the Banque de France's regional business network or alternative indicators such as credit card payments data.

### WHAT ARE YOU WORKING ON CURRENTLY?

I have been Head of the International Monetary Relations Division since 2022. I lead a small team of about ten people, mostly executives, economists. Some have PhDs, others have engineering degrees or attended *grandes écoles*. In my team, there is a young economist who is simultaneously preparing a thesis at AMSE, one of the few academic programs offering this «on-the-job» track.

The International Monetary Relations Division prepares the Governor of the Banque de France for G20 and G7 meetings. The meetings are less frequent than at the European level, and decision-making is less concrete. Finance ministers and Central Bank Governors participate in the «finance track» discussions. The final stage is meetings at the level of heads of state. These are forums for both political and economic coordination at the global level. Engagement is voluntary, and consensus is the rule.

Many discussions are about development financing and poverty reduction. For example, the Special Drawing Rights issued by the IMF after the Covid crisis and the options to channel them to the most vulnerable countries. Another example is a current discussion on global corporate taxation to avoid tax evasion. We are seeking an international agreement on a minimum tax of 15% on profits in all global jurisdictions.

Regarding the international situation of the Division, we work closely with the French Treasury and we have close contacts with the IMF. We brief the Governor to ensure the best outcome for France but also for the global common good in the spirit of multilateralism.

Another activity of the Division is monitoring 'emerging markets', which cover a very large, heterogeneous area. We particularly focus on the BRICS countries. Forecasting for France requires knowing the international environment in which the country operates; this is called foreign demand. Observing the trajectory of oil prices or exchange rates is crucial for forecasting inflation, for example.

## HOW DO YOU FEEL ABOUT YOUR TIME AT AMSE?

I did the Magistère, of which I have very fond memories. We worked on projects together with other students. This collaborative work prepares you for the professional environment, where you never work alone but always as part of a team.

The doctorate is a more solitary undertaking, but it developed my critical thinking. This is very useful in the professional world, both to promote one's own work and to challenge the work of others.

I remember receiving high-level education in a stimulating environment. I had remarkable professors. In econometrics, I remember Russell Davidson's course. I also remember Alan Kirman's course, where he used ants to explain how financial markets work - offbeat explanations that remain with me today.

- 16 articles published in journals of other disciplines such as health, mathematics, and medicine.

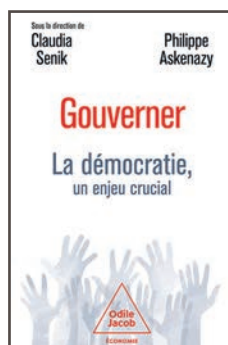

## The weakness of common job contacts

**Individuals with friends in diverse social circles may have better employment prospects than those with tightly clustered circles of friends**

### RESEARCH QUESTION

Imagine securing your job through a conversation at a dinner with friends. The saying «It's not what you know, but who you know» is not just a cliché, it is actually supported by empirical evidence. Studies reveal that between 30% and 50% of jobs are obtained through personal connections, highlighting the importance of understanding how social networks influence employment outcomes.

A stylized fact of real social networks is the presence of overlapping friendship circles: people's friends are often friends with each other. Empirical evidence documents differences in groups' propensity to form transitive relationships, representing a potential source of inequality in job seeking.

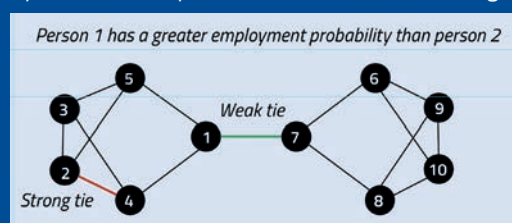
How do overlapping friendship circles impact employment? We delve into this question using a theoretical model. Individuals are connected within a network and receive random information about job opportunities. Employed individuals share this information with their unemployed contacts, while unemployed individuals retain the information for themselves. We examine the impact of overlapping friendship networks on both employment and wages.

events have a greater likelihood of occurring simultaneously. In our context, these events are receiving redundant information or no information at all. The identified effect of overlapping networks is not minor: individuals with friends in diverse social circles may have better employment prospects than those with tightly clustered circles of friends, even if the former contain fewer information providers or a greater number of job competitors.

Our research challenges two seminal studies on social networks in the labor market. First, we find that the results in Calvó-Armengol (2004) only apply in networks where individuals' friendships lack connections and shared contacts. Second, we offer a new perspective on Granovetter's (1973) theory of «The Strength of Weak Ties». This theory posits that people are more likely to find employment through weak ties—acquaintances with whom they have infrequent contact—than through strong ties—close family or friends. According to this theory, this is because weak ties connect individuals in different social settings, providing access to novel information. Our research demonstrates that weak ties—which according to Granovetter are likely to be those linking people with few or no mutual friends—are advantageous even when the content of the information provided by both types of ties is identical. Thus, the value of weak ties may not lie solely in the content of the information they provide, but also in their ability to effectively disseminate information. Regarding

### PAPER'S FINDINGS

We find that overlapping friendship networks generate stochastic affiliation in the information flows received by agents, reducing their employment probability. Stochastic affiliation is a strong form of correlation, where several

wages, individuals with overlapping friendship networks have lower incomes due to their higher unemployment probability. However, conditioned on being employed, they can be expected to earn higher wages, as they are more likely to receive multiple job offers to choose from.

### FUTURE RESEARCH

«The strength of weak ties» is, to date, the most cited work in all the social sciences. Numerous empirical studies have attempted to assess its validity, yielding diverse results. One possible explanation for this diversity might be that many of these studies do not provide information on the number of three-cycles people form with their contacts, and/or the number of squares they are embedded in. Examining both cycles' impact on employment might explain why empirical findings differ.

Secondly, our findings are based on the assumption that individuals share job information mechanically. However, the decision to share job information can also be strategic. Our understanding of the impact of networks on employment would benefit from exploring such strategic considerations when job information is passed on.

## Ramadan fasting increases leniency in judges from Pakistan and India

### RESEARCH PROGRAM

Rituals have significant implications for behavior and decision-making, even in domains expected to be objective, such as judicial decisions. Existing literature highlights how extraneous factors—like weather and political climates—can impact judicial outcomes, challenging the notion of impartiality. This study explores the influence of Ramadan, a prominent Islamic ritual, on judicial leniency and decision quality. Using a dataset spanning 50 years of criminal sentencing in India and Pakistan, this research examines whether the fasting and reflection inherent in Ramadan affect judicial adjudication.

### PAPER'S CONTRIBUTIONS

This paper makes several contributions to our understanding of judicial decision-making and the broader impact of rituals:

1. Empirical Evidence of Increased Leniency: The study finds that Muslim judges during Ramadan are 10% more likely to acquit with each additional hour of fasting. This increased leniency does not diminish judgment quality, as shown by a 4% decrease in the probability of reversed decisions in higher courts.

2. Conceptual Framework: The research identifies two channels through which Ramadan may influence judicial decisions: negative effects of physiological deprivation and positive effects of enhanced moral reflection. The findings suggest the latter channel predominates, given the lower recidivism rates and absence of bias against non-Muslim litigants.

3. Overcoming Empirical Challenges: The study addresses three key empirical challenges:

- Variation in Length of Fasting: By exploiting

geographic latitude differences, the study uses variations in length of fasting within the same day as a measure of ritual intensity. For example, during winter, daily fasting hours are longer in Tirunelveli than in Kupwara because Tirunelveli is closer to the equator. Conversely, in summer, the fasting hours in Tirunelveli are shorter than in Kupwara. This latitude-induced variation provides a natural experiment to isolate the impact of fasting intensity.

- Temporal Variation: The lunar calendar's shift across seasons allows the study to separate the effects of Ramadan from seasonal effects. This temporal variation helps ensure that observed effects are due to Ramadan itself rather than coinciding seasonal factors.
- Random Case Assignment: Random assignment of cases to Muslim and non-Muslim judges provides a natural experiment setting to isolate the impact of Ramadan. The decisions of non-Muslim judges serve as a control group, helping to confirm that the observed leniency is not a statistical artifact but a genuine effect of the fasting ritual.

By leveraging these variations, the study disentangles the effects of ritual intensity from broader societal and seasonal influences.

### FUTURE RESEARCH

This study paves the way for several future research directions:

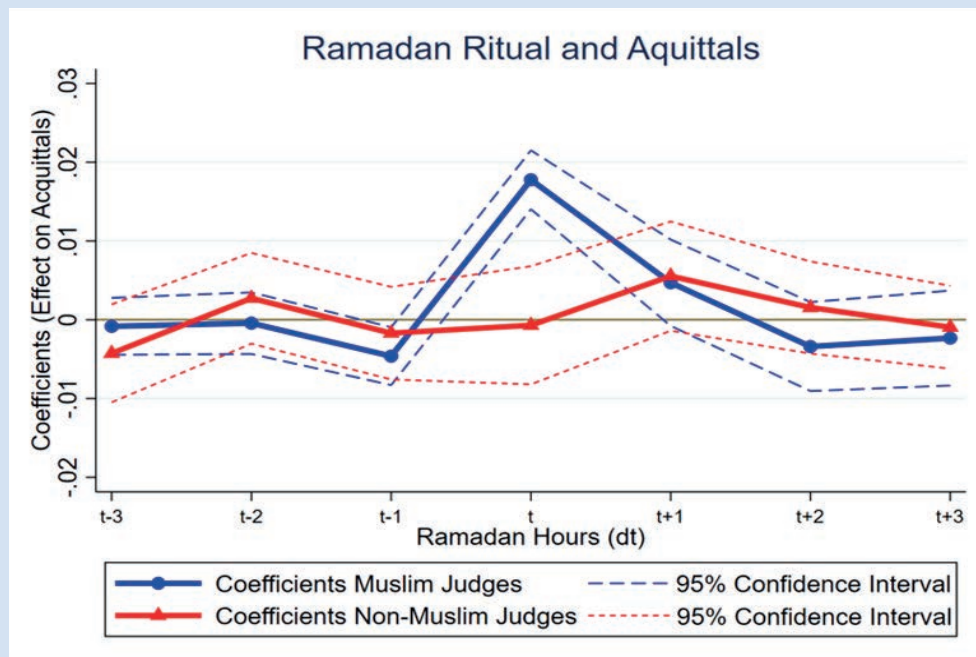
1. Mechanisms of Influence: Future research should delve into the psychological and physiological mechanisms driving increased leniency during Ramadan. Understanding whether cognitive changes, enhanced moral reflection, or other factors are at play could provide deeper insights.

2. Comparative Studies: Investigating the impact of other religious or cultural rituals on judicial decision-making in diverse contexts would help identify universal patterns and context-specific effects.

3. Long-Term Impacts: Examining the long-term effects of ritual-influenced decision-making on criminal justice systems, such as crime rates and prison populations, could provide valuable insights into the broader implications of these findings.

Continued research in these areas will enhance our understanding of the complex relationship between rituals and decision-making, leading to more informed policies and practices in judicial systems globally.

## On the (de)stabilization role of protectionism

He obtained his PhD from Université de la Méditerranée in 1994. He was a CNRS chargé de recherches at AMSE between 1995 and 2003, an associate professor at University of the Littoral Opal Coast, Boulogne-sur-Mer in 1995-96 and an associate professor at Ecole Supérieure de Mécanique de Marseille in 1996-97. His research interests lie in macroeconomics and economic growth.

### RESEARCH PROGRAM

With the recent re-election of Trump, the question of protectionism is once again at the center of debates. In 2017, after his first election, Trump raised trade barriers, especially tariffs on imports from China, Europe, and other emerging economies like Mexico. The primary argument for protectionism is to encourage domestic production and consumption, thereby fostering re-localization of productive activities within the country. The expected result for the US was to boost employment and growth while providing additional government resources. This policy naturally generated some reactions, in particular from emerging economies, who also raised their tariffs. However, it is not clear exactly what impacts their protectionist reactions had, particularly regarding macroeconomic stability and economic growth.

### PAPER'S CONTRIBUTIONS

In this paper, we analyze the impacts of an increase in tariffs by the government of a small open economy with high public debt and facing borrowing constraints on the financial market, a scenario typical of many emerging economies. Our main conclusion is that tariffs have a destabilizing impact. More precisely, under low interest rates and a large enough share of imported goods, increased tariffs may lead to the existence of two equilibria with two Balanced Growth Paths (BGP) – low and high. While the existence of high BGP is still ensured, due to high growth performances sustaining the debt level, higher tariffs also make low BGP feasible due to the government's ability to obtain more resources from the consumption of imported goods and thus compensate for low growth performances.

We also demonstrate that high BGP is always characterized by sunspot fluctuations, while low BGP is always a saddle point. Supposing that agents expect an

increase in growth: under high BGP, they may borrow, consume, and invest more via international borrowing (preventing a crowding-out effect, as the borrowing constraint is loose) and they will expect higher public spending. For given tariffs, therefore, the government's revenue can increase significantly, leading to an increase in public spending that generates a higher growth rate. The expectations are thus self-fulfilling. In contrast, low BGP is characterized by low growth performances and thus a lower public debt/spending to capital ratio. This implies tighter credit constraint, since the collateral needed to support borrowing is relatively low. Inflows of capital thus remain limited. Being more constrained, the agents consume less and decrease their investment in productive capital, even if they are expecting more growth. Unable to rely on tariffs in this case, the government does not invest enough and growth cannot increase, since there is limited income from consumption and tariffs. The expectations cannot be self-fulfilling and the equilibrium remains locally determinate.

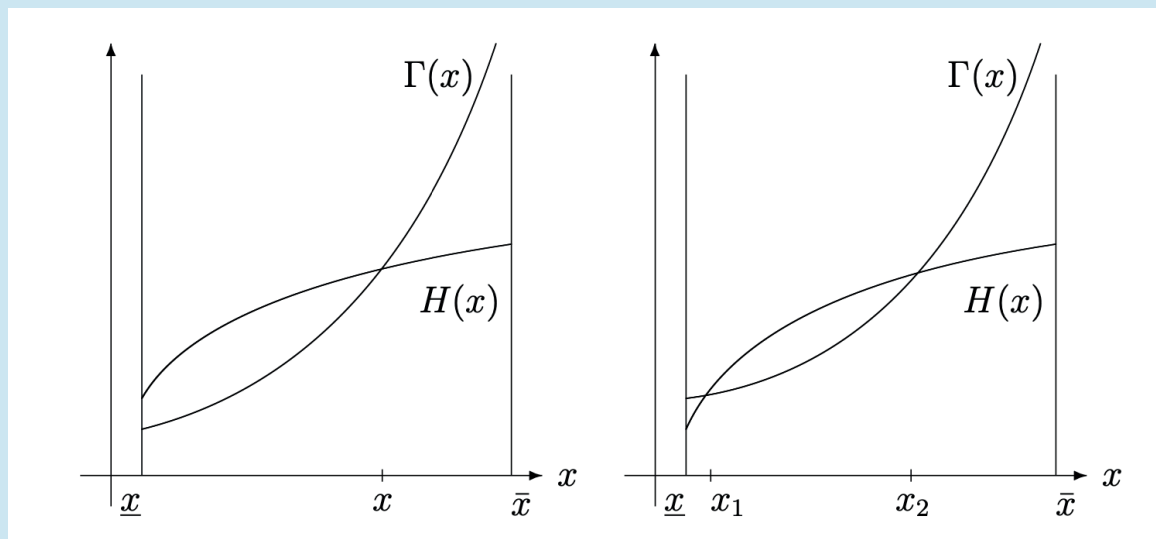
Finally, we conduct a comparative statics exercise on the impact of tariffs on stationary equilibria. We find that the high balanced growth rate is negatively affected by tariffs, while the low balanced growth rate is positively impacted. This difference arises from the sources of growth: in the high steady state, growth relies on government spending, whereas in the low steady state, growth is driven by private capital and investment. Increasing tariffs yields two opposing effects. Households invest less due to reduced income, but the government gains additional resources for public spending. In the high growth equilibrium, the negative impact on household income dominates, leading to a decline in growth. In the low growth equilibrium, the increase in government spending compensates for the loss in household income, resulting in higher growth.

## Research highlight

Overall, our findings therefore suggest a trade-off between growth and stability.

### FUTURE RESEARCH

Our paper examines the impacts of protectionism in a small open economy where only fiscal policy is implemented by the government. We do not consider the presence of a Central Bank in charge of monetary policy. A potential extension of our work could involve incorporating a Central Bank into the analysis so as to analyze a fiscal-monetary policy mix. Can coordination between fiscal and monetary authorities help restore stability when tariffs disrupt the economy?



*Figure : Uniqueness versus Multiplicity of BGP*

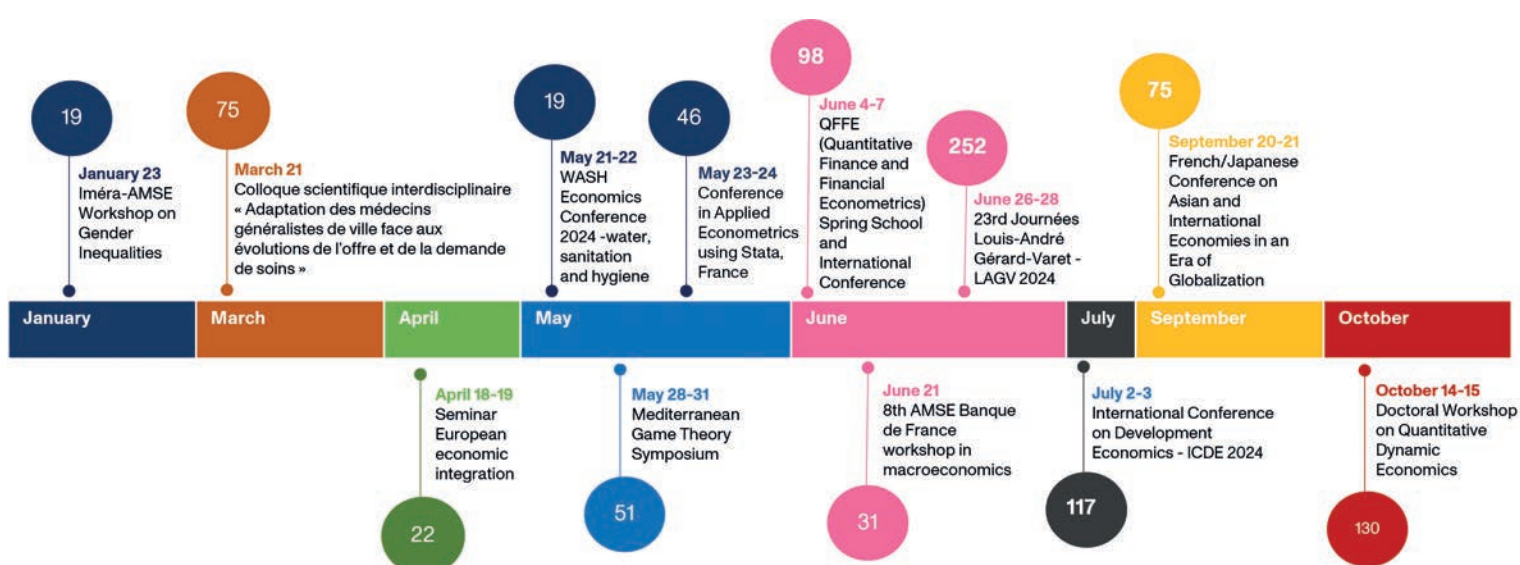

## Research Seminars

148 regular seminars were held at AMSE in 2024. These seminars provide a platform for researchers to present their ongoing work, receive constructive feedback, and engage in discussions that can lead to new insights and ideas. Additionally, the involvement of guest researchers from other institutions introduces fresh perspectives and expertise, which can encourage interdisciplinary approaches. AMSE offers a wide variety of seminars:

### AMSE Seminar

Presentation of papers addressing all economic areas by researchers from other universities, encouraging academic dialogue and collaboration within the community.

### Big Data & Econometrics Seminar

Expert researchers in theoretical and applied econometrics explore methodologies and applications of big data in econometrics, advancing research and practice in the field.

### Development & Political Economy Seminar

Development and International Economics seminar, presenting theoretical and empirical work on the subject.

### Eco-lunch

Informal seminar series where AMSE researchers and post-doctoral fellows present their research and share their ongoing work fostering casual yet insightful academic discussions and networking opportunities.

### Economic philosophy Seminar

An academic seminar exploring the intersection of economics and philosophy, where participants discuss fundamental questions about economic theories, methods, and their ethical implications.

### Economic Theory Seminar

External researchers present and discuss their theoretical, empirical, or experimental work on networks.

### Finance Seminar

Presentations by researchers in theoretical and applied finance.

### French- Japanese Webinar

Collaborative event bringing together experts from Japanese and French universities, research centers, and economic policy think tanks to exchange and share their research results on all aspects of economics.

### History & Economics Seminar

Study of these shared objects is enriched by comparing approaches and methods from a thematic viewpoint.

A seminar dedicated to interdisciplinary evaluation, bringing together researchers to share methods, findings, and perspectives on assessment and impact measurement.

### PhD Seminar

# Studies

We proudly observe what our students have achieved. The ability to learn and embrace new ideas that they have developed as they enter the business world is almost as important as the knowledge they have gained during their studies. EcAMSE is a department of the Faculty of Economics and Management within Aix-Marseille University.



## Professional Integration: the numbers tell the story!

Survey of employment six months after graduation conducted by AMSE among October 2023 graduates. The indicators do not account for students who started a PhD after their master's degree, nor those continuing their studies.

The latest graduate survey confirms AMSE students' excellent professional integration. Their skills are recognised and valued by employers, and they enjoy a wide range of career opportunities.

### Participation Rate: 77%

The participation rate for this survey, conducted among the 87 students who graduated from the AMSE master's program in 2023, is 77%, ensuring the representativeness of the results and demonstrating the graduates' commitment to tracking their professional paths.

### Average Time to Employment: 25 days

With an average of just 25 days taken to secure their first job, AMSE graduates benefit from a strong market demand for their skills.

### Employment Rate at 6 Months: 81%

Six months after graduation, 81% of AMSE graduates are professionally integrated — a strong result that reflects how well their skills align with employer needs. Notably, 66% of surveyed graduates were hired directly following their internship or work-study placement.

### Percentage of Permanent Contracts (CDI): 73%

Of the employed graduates, 73% have permanent contracts (CDI), compared to 27% with fixed-term contracts (CDD). The predominance of permanent contracts is an indicator of stability and employer confidence in the graduates' skills.

### Average First Annual Gross Salary: 39,350

The average annual gross salary of graduates who responded to our survey is €39,350. This competitive figure reflects the jobs market's recognition of the quality of AMSE training, as well as the potential for rapid salary progression for young graduates.

### Percentage of Graduates Working Internationally: 17%

AMSE graduates are employed in Paris and the Paris region (37%), elsewhere in France (46%), and abroad (17%), illustrating the international reach of their training.

### Sectors

AMSE's programs lead to high-potential jobs. The employment sectors that graduates can enter are varied, with a strong presence in Finance/Banking/Insurance (23%), Consulting/Design Offices/Survey Institutes (15%), Digital/Data/Technology (11%), Energy/Transport/Environment (13%), and Public Administration/Organizations/Research (6%).

### Range of Professions

The survey highlights the positions held by graduates: Data Scientist, Strategic Marketing Manager, Project Manager, Data Analyst, Junior Consultant, Macroeconomics Analyst, Finance Operations Manager, Data Engineer, Data Consultant, Quantitative Analyst, Analytics Consultant, Actuarial Study Officer, Research Assistant, Insurance Controller, Commercial Performance Analyst, Insurance Linked Securities (ILS) Analyst, Design Office Consultant,...

“

*I am a Data Analyst with Groupama Méditerranée, an insurance company, where I am mainly responsible for sales management and variable pay for the sales staff of the regional insurance company Groupama Méditerranée.*

*This is my first job. I was hired immediately after my work-study placement, and they created a position to keep me on a permanent contract.*

*I have several assignments. The first is to work on code programmes. I use the R programming language to set the parameters for variable pay. We compare data tables to obtain different types of information, to export files. But other responsibilities involve providing data analysis, i.e. a "Data" perspective on projects not necessarily focused on data alone, which requires cross-disciplinary perspective.*

*The fact that AMSE offers both theoretical and empirical economics as well as this whole "Data Science" aspect is very enriching. And today, I am very happy because I can really combine two complementary approaches in my work. However, not all schools offer Big Data and Economics at the same time. It was really a good compromise, showing the school's determination to keep enriching the curricula with knowledge and skills that take account of future developments, and which therefore will help us on the job market.*

## Launch of the new master accreditation

The re-accreditation process for the school's Master's degree program was launched in September 2024.

The new developments include:

- expansion of the school's scope through the integration of the Master's in Finance;
- creation of a Master's degree in Statistics and Econometrics;

- revision of the Master's program in Economics,

- a reinforced partnership with Sciences Po Aix as part of the Master's program in Economics,

The new offer is based on 3 distinct Master's programs:

- Master's in "Econometrics and Statistics". This new major includes a track in "Econometrics and Data Science" (EDS) and the track "Research";

- Master's in "Economics", an offshoot of the current Master's in economics, consisting of two M2 tracks: "Data, Analysis, Decision, and Economic Evaluation" (DADEE) and "Research". The DADEE program was enriched by adding a new option jointly offered by AMSE and Sciences Po Aix. This new option aims to train economic advisors with expertise in international relations for embassies, companies, and international organizations..

- Master's in "Finance", which integrates the newly named "Financial Modelling" track (previously "Quantitative Finance and Insurance" or FQA) as well as the three existing tracks: "Financial Risks and Sustainable Finance," "Wealth Management," and "Corporate Finance and Financial Engineering," along with the track "Research".

The Research track, shared by all three Master's, serves as the gateway to the AMSE doctoral program.

Except for Research, all tracks are open to apprenticeships.

This reform resulted in a significant increase in student enrollment. On the one hand, the integration of the Finance program brought in approximately 200 additional students. On the other hand, the improved clarity of our academic offering allowed the first year of the school's original Master's programs to nearly double their enrollment

## Exchange Program with the Universidad Autónoma de Madrid

Each year, three M1 students in the Master's in Economics program take part in a week-long exchange with the Universidad Autónoma de Madrid.

Madrid organized the activities in two parts, both addressing Social Network Analysis in Economics and using the software Python.

In Part 1, the students worked together in two groups, (each containing both AMSE and UAM students). They met on the first day for information and instructions on the activities to be performed together throughout the week. The students worked together on these activities in a working space at the Faculty. On the last day, they presented the results of their work to the rest of our Master students.

In Part 2, the students participated in a workshop on the topic, both theoretical and empirical, during which they worked with Python code provided by the instructor for the analysis of social networks.

In addition, they attended two research seminars.

The feedback from the students indicates that it was a great experience from the academic and personal viewpoints, for both the AMSE students (Roxane, Vanessa, Brayan and Gianluigi) and the UAM students (Darío, Nino and Nacho).

Academically, the task assigned to us offered a valuable opportunity to deeply explore the concept of network, a topic with which I had limited familiarity prior to this exchange. I found this intriguing and also highly relevant to other subjects covered this semester in Marseille, creating meaningful connections across my studies.

Additionally, I appreciated the chance to compare my own academic environment with that of my Spanish colleagues. Although our programs differ slightly, we share similar aspirations, uncertainties, and questions about our future career paths. Engaging with them provided a unique perspective and reinforced a sense of shared purpose which is highly motivating.

The Spanish team, including both students and faculty, was exceptionally supportive and welcoming. They showed genuine concern for our well-being, which made me feel appreciated, supported, and truly part of the group, allowing me to work in a comfortable environment.

## Annual Career Day

Every year, AMSE organizes its Career Day, a flagship event for the school and a unique opportunity for students to shape their professional future.

### A springboard for students

Career Day offers students a valuable opportunity to meet professionals from the fields they aspire to join. These interactions help them build a solid network—essential for securing internships, apprenticeships, or jobs. *“When you’re a student, it’s crucial to connect with professionals as early as possible. It helps you shape your career path and discover roles in your chosen field,”* explains Audrey Triyeh, a 2021 graduate of the Wealth Management track and now a Private Banker for managing shareholders at BNP Paribas. In addition to networking opportunities, practical workshops—such as CV and LinkedIn profile optimization—equip students with the tools they need to meet job market expectations.

### A bridge between university and business

For companies, Career Day serves as a prime opportunity to identify new talent and better understand the diversity of profiles coming out of AMSE. The event also showcases the school’s alignment with industry demands and evolving professions. *“Participating in the Career Day was a unique chance to spotlight careers in the civil service, which are often underrepresented, and to show how the skills acquired at AMSE can address today’s major challenges,”* emphasizes Axelle Renaud, a 2024 graduate of the Economic Policy Analysis track and European Project Manager with the Ville de Marseille. Additionally, the event strengthens partnerships between the school and businesses, bolstering AMSE’s appeal and credibility among recruiters.

### Inspiring graduates

The alumni network plays a key role at Career Day. Former students share their experience, offering guidance and inspiration to future professionals. *“As a student, transitioning from university to the workplace can feel overwhelming. Our stories help guide students by highlighting the strategies they can use to succeed while reassuring recruiters about the quality of AMSE graduates,”* explains Baptiste Waignon, a 2024 graduate of the Financial Risk Management track and Risk Management Officer at Baloise in Luxembourg. This transfer of knowledge and such commitment from the alumni show their loyalty to the school and make a valuable contribution to its reputation.

### An event with multifaceted impacts

AMSE Career Day delivers three key messages:

- To students: «We are preparing you to succeed in the professional world»,
- To companies: «We are training the talent you need»,
- To graduates: «Your involvement contributes to a thriving community».

## AMSE Afterworks Targeted meetings between students and professionals

AMSE regularly organizes afterworks—exclusive networking events between its students and local or national companies. These small-group gatherings aim to strengthen the link between academic training and the professional world.

For companies, afterworks are an opportunity to enhance their employer brand, showcase their professions in a concrete way, and directly connect with students with recruitment in mind, particularly for internships.

For students, these events are a chance to expand their network, gain a clearer understanding of the career opportunities their education offers, and draw inspiration from diverse professional paths.

These meetings are not open to the public and are organized around pre-defined themes to ensure the presence of the most relevant student profiles.

## PhD program

In 2024, the PhD program maintained its dynamic approach by continuing to offer a wide range of courses taught by both internal and visiting faculty. These courses are now structured into three modules: "Topics in Economics" – advanced courses in economic theory and applications; "Methods" – courses in advanced applied methods with a strong focus on big data; and "Professionalization" – practical training in job-market-oriented skills such as presenting, academic writing, and understanding the publication process. These core modules are enriched by regular reading groups, where PhD students present and discuss recent frontier research.

International mobility also remained a strong feature of the program in 2024. Several PhD students completed research visits to leading universities in Europe and North America, such as the London School of Economics, the University of British Columbia, and Yale University – a practice that continues to foster exposure to cutting-edge academic environments.

The one-year visiting fellowships for PhD candidates nearing completion at other institutions were again renewed. Four fellows from Sciences Po, Paris Dauphine, the European University Institute (Florence), and Queen Mary University (London) spent the academic year at AMSE, finalizing their dissertations while actively engaging with the AMSE research community.

Support for job-market preparation also remained a central priority. PhD placement officers continued to provide tailored guidance through training sessions, mock interviews, and job-talk rehearsals. They also closely monitored candidates' progress and helped establish connections with potential recruiters, both in France and abroad.

Since 2021, the PhD program has produced short videos showcasing job-market papers, available on the AMSE website. This initiative has continued to raise the visibility of our candidates. The most recent graduating cohort has successfully secured academic positions across a wide range of institutions and countries, including France, Belgium, Luxembourg, Spain, Denmark, the United States, and Japan.

## 5th AMSE Summer school *"Discounting, risk, and the environment"*

The 2024 AMSE Summer School covered recent theories and empirical approaches of discounting future benefits and costs, with a special focus on uncertainties surrounding environmental outcomes.

How people assess environmental consequences and risks, or policy actions is a crucial question, as many global environmental changes are characterized by long outcome delays. For instance, depletion of natural resources or biodiversity losses may have very severe long-term effects which will take decades to develop fully. Likewise, climate decision-making involves measuring carbon values over time, and may be sensitive to uncertain consequences.

Temporal discounting and the evaluation of environmental risks and uncertainties play a significant role in decisions and policy actions. The choice of an appropriate discount rate is, however, a controversial issue in economic analysis, especially when the future consequences are associated with deep uncertainties.

While the economic theoretical literature used to assume a constant discount rate, a recent literature addresses the relevant question on the appropriate value of that rate and the role of uncertainty in the valuation of long-term environmental issues.

During the three days of the Summer School, participants had rigorous and in-depth exposure to the most recent theories and empirical methods applied to discounting the future.

AMSE summer school attracted graduate students or academics wanting to expand their knowledge in this area of research and practitioners seeking to familiarize themselves with the key advances in theoretical and empirical models at the junction between environmental economics and decision theory.

Participants had the opportunity to present their research in workshops during the summer school, which took place in Marseille.

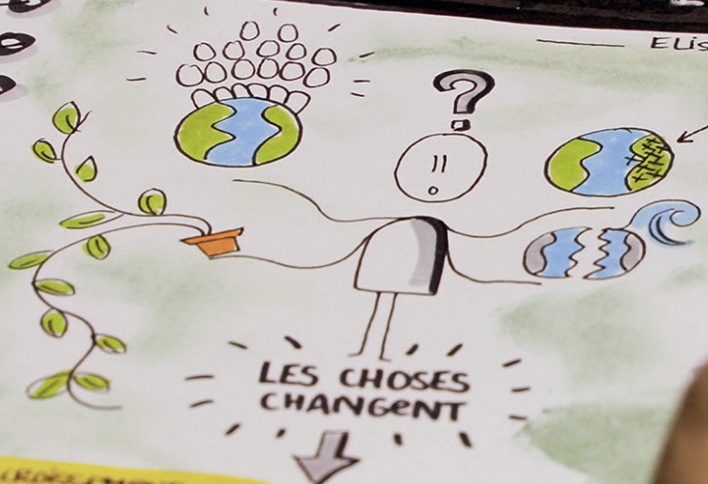

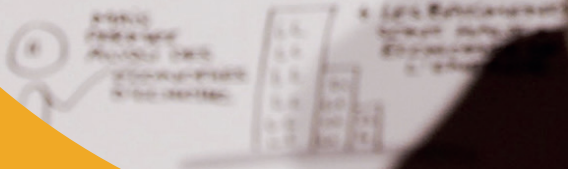

# Public Outreach

Alongside its missions in Research and Training, GSR AMSE promotes dialogue between science and society through its dedicated Public Outreach unit. Economic research is made accessible to a wide audience — from citizens, journalists, students, teachers and policymakers.



## Dialogues économiques

In 2024 *Dialogues économiques* celebrated its **5th anniversary**.

*Dialogues économiques* is a bilingual (French/English) online publication designed to bring academic research in economics to the general public. It serves as a gateway between scholarly knowledge and societal concerns.

How does it work? An editorial committee, composed of 6 AMSE researchers and the Public Outreach team, selects peer-reviewed articles published in international journals to feature in the publication. Only research articles are considered; opinion pieces, reports, or working papers are excluded.

Each article is co-written by researchers and science journalists. Infographics that visually illustrate scientific papers' key figures or ideas enrich the articles, as well as video-interviews.

New articles are released every two weeks, in both French and English. Each piece is designed to be read in 3 to 4 minutes. The topics covered reflect the broad diversity of AMSE's research area.

Also published on the CNRS Le Journal blogging platform, *Dialogues économiques* has consistently ranked among the platform's most-read blogs since 2021.

A printed annual magazine compiles the year's articles and is distributed to partners, preparatory classes, and university libraries, offering a high-quality educational resource.

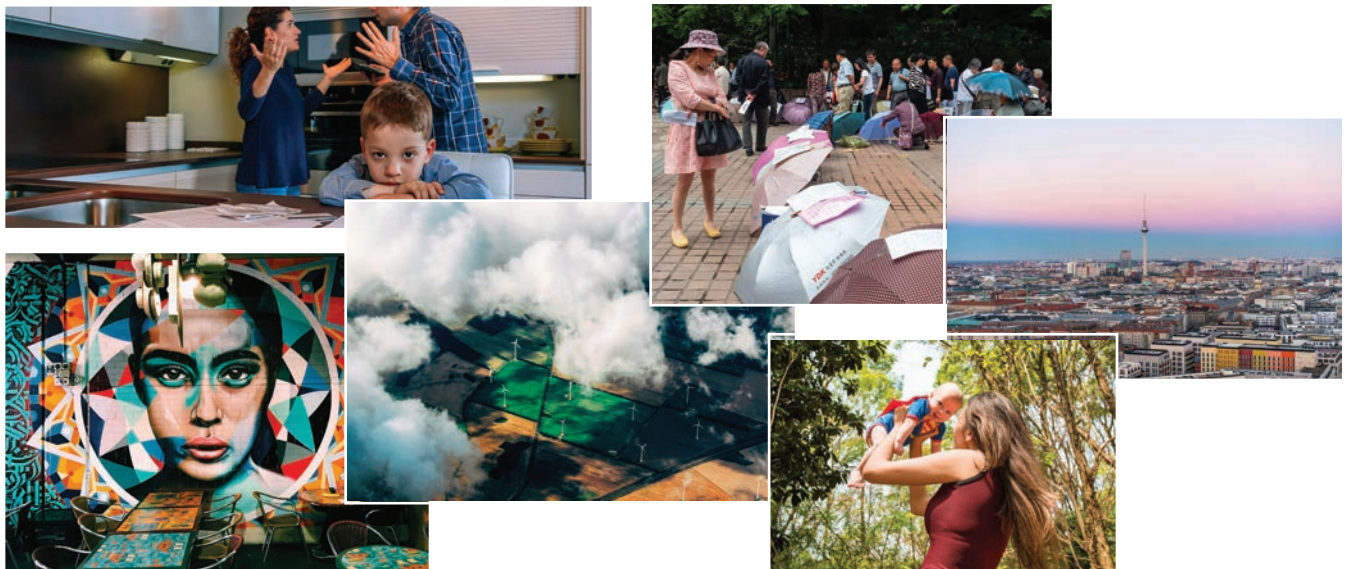

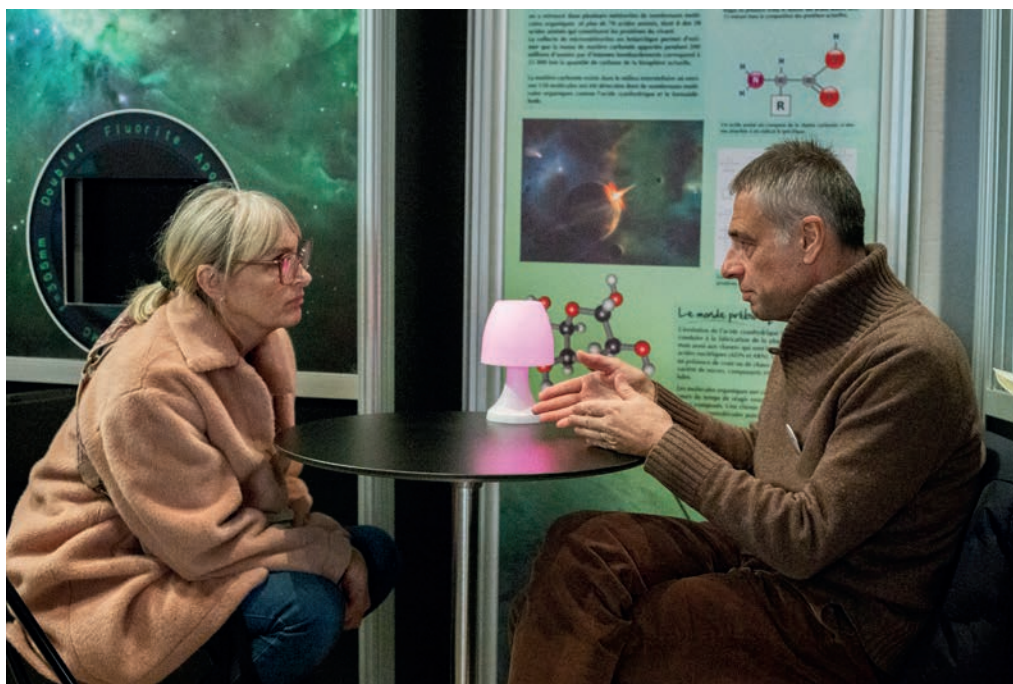
## Public outreach

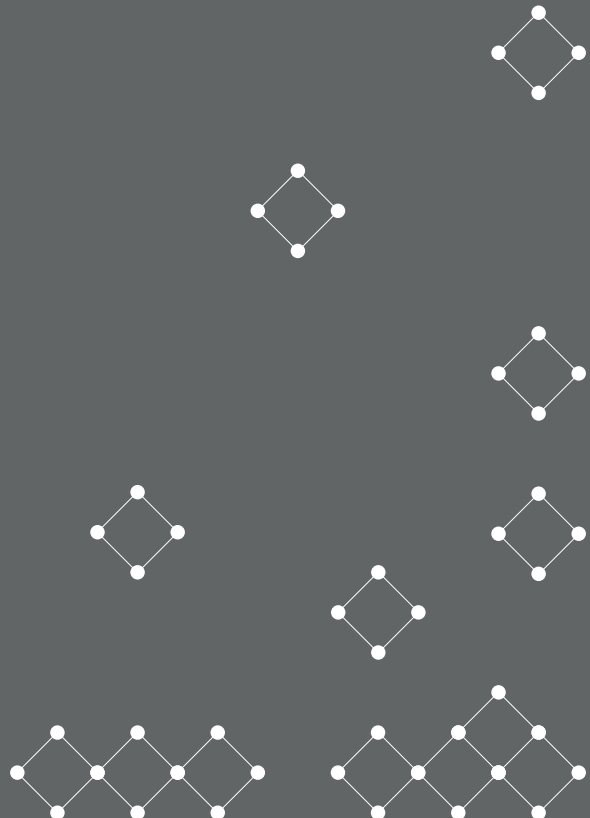
